Contributors

Gordon Boyce is dean of the Newcastle Business School in Australia and director of the Center for Institutional and Organisational Studies. His research interests include interorganizational cooperation and institutional economics. He writes about the shipping, steel, and finance industries.

Ludovic Cailluet is associate professor of international management and strategy at the Toulouse University Graduate School of Management, where he has taught in the Strategy Department since 1998. He has published his research on the history of aluminum, consulting, and commercial vehicles, as well as on strategic management. Most recently, he worked with Richard Whittington on a research project entitled “The Evolution of Strategy Practice: Long-Run and International Perspectives.”

Matthias Kipping is professor of strategic management and chair in business history at the Schulich School of Business at York University in Toronto. His main research interest is the international diffusion of management knowledge. He is currently coediting *The Oxford Handbook of Management Consulting* and finalizing *The Consultancy Business in Historical and Comparative Perspective*, both to be published by Oxford University Press.

Christian Kleinschmidt is professor of economic and social history at the Philipps Universität Marburg and author of *Der produktive Blick: Wahrnehmung amerikanischer und japanischer Management- und Produktionsmethoden durch deutsche Unternehmer, 1950–1985* (2002) and *Konsumgesellschaft* (2008).

Ingo Koehler is assistant professor of economic and social history at the University of Goettingen. He is author of *Die “Arisierung” der Privatbanken im Dritten Reich: Verdrängung, Ausschaltung und die Frage der Wiedergutmachung* (2005). An English edition of his book on the Aryanization of German private banks in the Third Reich will be published in 2011. Most recently, he has been conducting research on the history of the German automobile industry in the 1970s.

Lucy Newton is senior lecturer at the Henley Business School, University of Reading. She has written about the banking and financial history of nineteenth-century England and Wales. Currently, she is working on

the development of marketing and advertising by British banks between 1920 and 1970. She was a trustee of the Business History Conference from 2004 to 2007 and a council member of the U.K. Association of Business Historians from 1997 to 2000.
