SOVEREIGNTY WITHIN THE LAW

"This good book answers critics of *The Common Law of Mankind* published by Dr. C. Wilfred Jenks in 1958; they objected that the nations could never be brought to submit to supra-national law acting on 'sovereign' communities from outside; the notion was fanciful. But Dr. Jenks thinks cynics and pessimists have no monopoly of common-sense. So Professor Larson and he, with a research team of the Rule of Law Research Centre of Duke University, U.S.A., have procured and set out in this book opinions from distinguished jurists in fifteen major oriental and occidental legal systems, to show that in all of them the rule *sub lege rex* is (by now at any rate) preferred to *princeps legibus solutus*. If therefore, the argument runs, so many races assert the superiority of law over ruler at home, they may well respect it as citizens of the world: and mankind be enabled to find justice with peace under the rule of world law.

"Professor Larson's scholarly, articulated chapters on the cases, the practice, customs, conventions and the findings of tribunals complete a competent thesis.

"The type used is beautiful, the index full, spare pages are provided for notes, the English very readable but the cover is undistinguished."
