The Convention on the avoidance of statelessness in relation to State succession provides that signatory States shall "take all appropriate measures to prevent persons who, at the time of the state succession, had the nationality of the predecessor state, from becoming stateless as a result of the succession."

Permanent Court of Arbitration (PCA): In the Matter of an Arbitration between: Barbados and the Republic of Trinidad and Tobago, Introductory Note by David A. Colson

Barbados initiated arbitration proceedings relating to its maritime boundary with the Republic of Trinidad and Tobago pursuant to Article 286 of the 1982 United Nations Convention on the Law of the Sea ("the Convention"). This award represents the first maritime boundary award under Annex VII to the Convention.

London Court of International Arbitration: EnCana Corporation v. The Republic of Ecuador, Introductory Note by Devashish Krishan

This dispute was the second arbitration brought against Ecuador under a bilateral investment treaty relating to VAT-refunds in Ecuador's oil industry. The arbitration panel held that EnCana's claims, except for those made under Article VIII (expropriation) of the bilateral investment treaty, were outside of the jurisdiction of the tribunal. The panel found that there was no expropriation and dismissed EnCana's claim.

United Kingdom House of Lords: R. v. Jones et al. (Conjoined Appeals), Introductory Note by Donald M. Ferencz

The issue before the House of Lords was "whether the crime of aggression, if established in customary international law, is a crime recognized by or forming part of the domestic criminal law of England and Wales." Lord Hoffmann stated in his opinion that "[t]here is no doubt that this [the crime of aggression] is a recognised crime in international law."

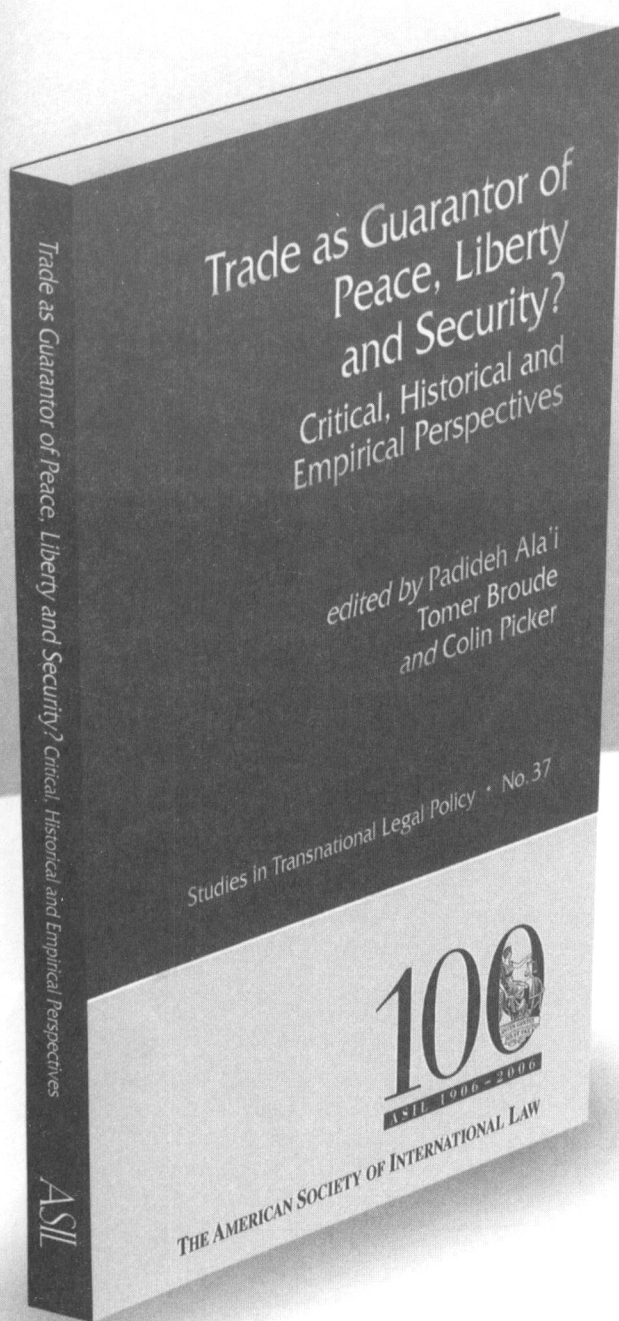
Bolivia: Presidential Supreme Decree 28701 (Nationalization of Hydrocarbons Sector), Introductory Note by Alejandro A. Escobar

The Society's history, *The American Society of International Law's First Century: 1906-2006* by ASIL Secretary Frederic L. Kirgis was published by Martinus Nijhoff Publishers in early 2006. This work not only reflects on the Society's development as an institution, but also places this development in the context of world events in the 20th century. With hindsight, we know that the 20th century was a tumultuous one. It was, however, also an exceptionally productive one for international law. For multilateral treaties alone, the twentieth century saw the conclusion and adoption of more such treaties than in the 250 years following the Peace of Westphalia in 1648.

It is therefore no surprise that one of the important initiatives ASIL took from its founding was to collect, to report on, and to make accessible important international legal materials. To this end, for the Society's first 55 years, documents appeared as part of the *American Journal of International Law* either in an Official Documents section or in supplements. In the early 1960s, the Society's Executive Council approved the preparation and publication of a periodical dedicated to identifying and disseminating important international law materials; since 1962, *International Legal Materials* has appeared six times a year and is now recognized worldwide as an important source of information on international law. *ILM's* mission to identify, to report on, and to make available such materials continues and now extends beyond print. The *ILM* editors and staff produce the electronic awareness bulletin, *International Law In Brief*, that is delivered to users by e-mail and can take them directly to materials available on the Internet.

As the Society looks to its second century and rededicates itself to its founding purpose to advance international law, we remain committed to providing the highest quality information to the broadest possible audience. *International Legal Materials* and its related suite of products are a central part of this mission.

Guidelines for Submission of Documents

The ILM Office welcomes any effort to bring suitable documents to the Office's attention. Electronic files or web links are required for publication, although printed texts can be used for initial deliberations regarding republication.

The authenticity (*i.e.* official version status) of submitted documents must be easily verifiable. This is facilitated by submitting files or print versions which are clearly attributable to the original source, or by providing links to documents on the original source's official website.

If the official version of a document is not available in English, an unofficial translation is acceptable. The original text must accompany such a translation.

Introductory Notes

Introductory Notes are brief articles from one to three pages in length which are intended to provide background information for a document reproduced in ILM.

For example, an Introductory Note for a treaty might include a short history of the negotiations, the dates of signature and entry into force. An Introductory Note for legislation would give its history and international significance, while one for judicial proceedings would provide the background of the case.

Acceptance of Materials and Corrections

Print submissions cannot be returned. Translators and others submitting material will be notified of the acceptance of their document for publication.

Once a translation or Introductory Note has been accepted for reproduction, The American Society of International Law will send a publication agreement to the author.

Translators and Introductory Note Authors shall be acknowledged in *International Legal Materials*.

In some cases minor editorial or typographical alterations may be made without contacting the author or translator. Major corrections will be sent to the author or translator for approval. Corrected Introductory Notes or translations must be returned within the time specified.
