These essays by distinguished historians and critics look afresh at the remarkable group of American novelists which emerged during the 1920s—that period of change, passion and experimentalism beginning after the First World War and reaching its climax in the Great Depression. The great names are of course William Faulkner, Ernest Hemingway, Scott Fitzgerald, John Dos Passos, Nathanael West, Sinclair Lewis and Sherwood Anderson. But this book, while looking at these and other novelists in detail, is also an exercise in cultural studies. It has been assumed that it is important and necessary, in considering these writers whose merits are still the subject of intense discussion and disagreement, to look behind them at the decade of the twenties itself—years that saw the transformation of American culture and the start of a new stylistic era. These essays thus re-examine the complex relationship between literature and culture, and in terms of this re-assess the importance of particular authors, reconsider the success of the American experiment in fiction and re-evaluate the quality and effectiveness of their radicalism and moral commitment.

Lawrence, Hardy, and American Literature

Dr Swigg is concerned in this impressive study with the relationship between D. H. Lawrence and certain earlier authors explored in his criticism—Hardy, and the Americans, Cooper, Hawthorne, Poe, and Melville in particular—to the end of illuminating them, independently of Lawrence, and also of showing the contribution they made to Lawrence's creative growth. Based on close readings of *Sons and Lovers*, *The Rainbow*, and *Women in Love*, as well as *Studies in Classic American Literature*, the book is notable for the breadth and originality of the critical argument it erects on these readings. £4.75

A Reading of Stephen Crane

A Reading of Stephen Crane is the only book available which considers all of Crane's work: fiction, poetry, and the more important newspaper writings. It argues that Crane's view of life is naturally ironic, that his work is not naturalistic, and that his important fiction is based upon a comparatively simple plot—a psychological progression to awareness which recurs from story to story. This in itself is the artistic expression of his irony, and Crane's poems and his letters to Nellie Crouse present the ironist's moral norm by means of which he was able to transcend and control his own ironic vision. £2.75

NOTES FOR CONTRIBUTORS

1. All contributions and editorial correspondence should be sent to: The Editor, *Journal of American Studies*, Department of American Studies, The University, Manchester M13 9PL, England.
2. Articles should generally contain about 5000 words. Longer or shorter articles, or articles in two or more parts, may be accepted by arrangement with the Editor.
3. Submission of an article is taken to imply that it has not previously been published, or is not being considered for publication elsewhere.
4. Contributions should be clearly typed in double spacing, preferably on A4 paper, with a wide left-hand margin. Diagrams and maps may be included by arrangement with the Editor.
5. Footnotes should be used sparingly: in general, to give sources of direct quotations, references to main authorities on disputable questions, and evidence relied on for a new or unusual conclusion. They should be numbered in one sequence throughout the article, and should preferably be typed in double spacing at the end of the article.
6. Contributors should keep one copy of the typescript for correcting proofs.
7. Notes intended for the Editor or printer should be on a separate sheet.
8. First proofs may be read and corrected by contributors provided that they can give the Editor an address through which they can be reached without delay and can guarantee to return the corrected proofs to the Editor, by airmail where necessary, within ten days of receiving them.
9. Correction should be kept to an absolute minimum. It should be confined to errors of the typist or printer unless the Editor authorizes otherwise.
10. Contributors of articles and review articles receive 25 free separates. Extra copies may be ordered according to the scale of charges.
11. Contributors need not be members of the British Association for American Studies. Unsolicited typescripts can only be returned to overseas contributors who send International Reply Coupons (not postage stamps).
12. Contributors of accepted articles will be asked to assign their copyrights, on certain conditions, to Cambridge University Press, to help protect their material, particularly in the U.S.A.
