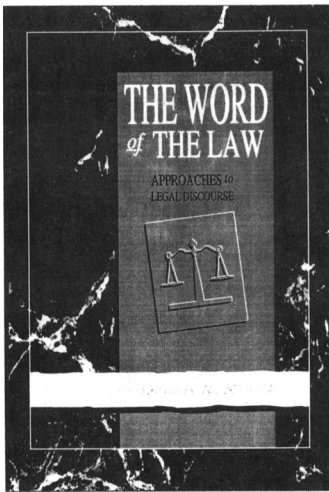

Approaches to Legal Discourse

Legal language is studied in new and interesting ways in this volume. The author makes an important contribution to the new and growing interdisciplinary field of law and literature by outlining how linguistics can illuminate legal discourse. The volume offers methods of critical analysis of the medium through

which law finds expression—language—and, by implication, of law itself. Topics included are:

- the relationship of language to perception and thought
- semiotics – accounts of signification generally, and kinds of signifiers
- the interplay of factors in the interpretation of texts
- what the notion "legal language" might involve
- rhetoric at the level of discourse
- style as a function of diction; style as a function of syntax
- analysis of narrative structure and devices
- metaphor and non-literal language use
- aesthetic assessment of texts

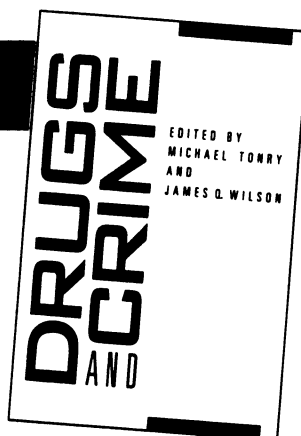

Drugs and Crime illuminates the complex relations between drug use and crime and the formidable challenges they pose. Evaluating various public policies of prevention, treatment, and law enforcement, the contributors offer dynamic analyses of what are traditionally (and sometimes ambiguously) seen as supply-reducing and demand-reducing strategies. The authors of these ten commissioned essays show why some popular remedies (such as certain kinds of drug education and efforts to curtail international smuggling) may not be effective. Without proposing magical solutions, they describe the most promising approaches to one of America's worst social problems.
