This project is designed to study the Mexican-American populations in various sections of the U.S. and analyze their patterns of acculturation. A listing of the projects which form this over-all study are: 1) Intensive study in Los Angeles and San Antonio. These two localities represent the heartland communities of Mexican-Americans in the Southwest. They account for one-quarter of the Mexican-American population in the entire region and are the major terminals of migration. Field work includes household surveys, intensive contacts with selected families, a study of the overall community within which Mexican-Americans live and function, and their relations to local power and social structure. 2) An analysis of the Spanish-American population in New Mexico. Analysis will include rural as well as urban places and will seek to test the wide-spread notion that this population in many respects is distinct from the rest of the Mexican-American minority in the Southwest. The apparent rapid social change that occurs among Spanish-Americans in New Mexico is of particular interest in this connection. 3) Community analysis of Mexican-Americans in East Chicago, Indiana. This community is part of the great Chicago complex. The analysis is

undertaken mainly to see whether Mexican-Americans in a Northern industrialized, and highly urbanized type of place have fared differently from the Southwest and in what respect. A series of advance reports began appearing at the end of 1965 and are continuing to be put out by the Graduate School of Business Administration's Mexican-American Study Project. The researcher has recently been in the Valley of Oaxaca, Mexico, gathering information to review contemporary anthropological theories of economic change, or to generate new ones by investigating the impact of modern national and international economic forces upon the traditional market system and economy. The traditional peasant market system of Oaxaca, Mexico, which has deep historical roots, has only recently come under heavy influence from the developing modern national economy. The data from this study will be useful: in evaluating various aspects of anthropological and economic theory in relation to a non-Western economy; in studying the changes of the community as they relate to problems of economic development; and in offering information which will help general development programs in countries characterized by traditional peasant economies. The project will be conducted in three stages: 1) Baseline studies will be made of the contemporary indigenous societies of Venezuela, critically reviewing all existing ethnographic information from the Conquest to the present, and bringing this source material together in regional handbooks, the first of which has been published by the researcher, entitled *Indios de la Región Orinoco-Ventuari*. Each regional handbook will contain a resumé of research and the ethnographic information Wilbert has gathered during six years of intensive research in Venezuela. 2) Four diagnostic studies will be made of typical tribes of Venezuela who will be chosen on the basis of the achieved developmental stages of their indigenous cultures. 3) A *Handbook of Venezuelan Indians* will critically summarize the available material and present it in a practical form for institutions interested in the study of culture morphology. This study will be on the operating methods of leading stock exchanges of the world, with particular reference to their function in the country's economy. They are studied for: their history, with particular reference to the situations from which they evolved; a description of the nature of securities listed for trading; the organization of the exchanges; methods employed to determine "the price that maximizes turnover"; relationship of investors to brokers; types of trading permitted; and importance and place of the exchange in the countries' economy. To be published as a monograph by the University of Michigan, Graduate School of Business Administration. In preparation. Began, June 1965.
