The Status System and Social Organization of Satsuma

Satsuma, a feudal domain in southern Kyushu during the Tokugawa period, was ruled by one of the most powerful clans in Japan. This volume provides a richly detailed view of the Satsuma social organization and status system up to the midnineteenth century and provides clues to the basis of the Satsuma political strength and leadership that enabled the clan to lead the Restoration movement. The Satsuma's strict policy of social control is analyzed through an examination of the Jōmoku or Regulations of Satsuma, which dealt with the registration and investigation of religious sects and the use of identification tags.

A team of five translators undertook the difficult task of rendering the pre-Meiji text of the Jōmoku into English. Professor Sakai's detailed introductory essay is mainly intended to suggest ways of organizing or interpreting the data, but it also provides a brief historical background beneficial to readers not familiar with this period of Japanese history.
