## Surgical Techniques in Experimental Farm Animals

F A Harrison (1995) Oxford University Press: Oxford. 159pp. Hardback. Obtainable from the publishers, Walton Street, Oxford OX2 6DP, UK (ISBN 0 19 854258 5). Price £50.

This book outlines the procedures to be followed when using farm animals in surgical studies of biological processes. Chapters 1 and 2 establish the planning and management necessary to carry out such experiments, with emphasis on minimizing animal discomfort/pain and the number of animals used. Chapters 3 to 9 deal with the various techniques.

# Conservation of Endangered Species in Captivity: An Interdisciplinary Approach

A multi-disciplinary approach to the conservation of endangered species in captivity. The book is organized by taxonomic groups: invertebrates; fishes; reptiles and amphibians; birds; marine mammals; primates; and other mammals. Within each group conservation, reproductive physiology, behaviour and captive design are considered.

## Stress: Conceptual and Biological Aspects

The author aims to integrate the different areas of stress research, and to describe the relationship between behavioural phenomena and the biological foundations of stress. It offers a framework for the definition of stress. This book is for students and scientists of psychology, physiology, medicine, ethology and veterinary sciences.

# Farm Animal Welfare: Social, Bioethical and Research Issues

Professor Rollin outlines animal welfare problems in agricultural practices and the current research which could lead to improvements. He also proposes areas for further studies. Suitable reading for animal producers, agricultural scientists, veterinarians, animal advocates and the general public.

The British Medical Association has reviewed the distribution of rabies world-wide and the suitability of methods of control and treatment. Included is an outline for dealing with a possible outbreak in Britain, as well as two models for safeguarding Britain's rabies-free status. Essential reading for policy-shapers, enforcers of Customs controls, doctors and veterinary surgeons.

## Managing Vertebrate Pests: Rabbits

Kent Williams, Ian Parer, Brian Coman, John Burley and Mike Braysher (1995). Bureau of Resource Sciences/CSIRO Division of Wildlife and Ecology. Australian Government Publishing Service: Canberra. 284pp. Paperback. Obtainable from the publishers, GPO Box 84, Canberra, ACT 2601, Australia (ISBN 0 644 29623 2). Price AUS\$25.94.

A comprehensive review of rabbits in Australia, including their history, distribution, biology, impact and use. Community attitudes are examined including animal welfare groups, Aboriginal people, commercial and recreational groups. Past and current management techniques are discussed and the authors set out strategies for control. The final chapter deals with deficiencies in knowledge, techniques and legislation. This is essential reading for policy makers, farmers and land managers.

# The Frankenstein Syndrome: Ethical and Social Issues in the Genetic Engineering of Animals

The author discusses the moral and social issues which are raised by the genetic engineering of animals. Chapter one deals with the idea that genetic engineering is 'against nature' and therefore wrong. Chapter two outlines the potential dangers, and Chapter three, the final chapter, concerns the welfare of these newly created animals. For scientists, policy makers and those with an interest in genetic engineering.

## Managing Vertebrate Pests: Foxes

A comprehensive review of foxes in Australia, including their history, biology, distribution, impact and use. The implications of rabies spreading to Australia and the associated fox management are discussed. Attitudes of different groups in society are examined as are past and current management practices. The authors set out strategies for control, and point out the deficiencies in current knowledge and approaches. Essential reading for policy makers, farmers and fauna reserve managers.

## Animals, Property and the Law

Gary Francione discusses how American law impacts animals. The book is divided into three parts: 'The status of animals as property'; 'A general application of the theory: anticruelty statutes'; 'A specific application of the theory: the regulation of animal experimentation'. It will be of interest to professionals in law, philosophers, governments, veterinarians and anyone interested in how we treat animals.

## The Domestic Dog: Its Evolution, Behaviour and Interactions with People

This is a comprehensive account of the domestic dog's natural history, behaviour and role in human society, based on scientific and scholarly evidence. Essential reading for anyone seriously interested in dogs.
