E. M. BECK is Associate Professor of Sociology at the University of Georgia. His current research centers on the historical political economy of the American South, class conflict among whites, and violence against blacks.

MALCOLM M. FEELEY is Professor of Law and Chair of the Center for the Study of Law and Society at the University of California at Berkeley. He is the author of a number of books and articles on the criminal process and is currently working on several projects, including a study of the impact of litigation on conditions in prisons and jails, a history of plea bargaining, and an analysis of women defendants in the criminal process.

JAMES L. MASSEY is Assistant Professor of Sociology at Northern Illinois University. He received his Ph.D. from the University of Iowa. His research interests are in the areas of historical criminology and the empirical examination of criminological theories.

MARTHA A. MYERS is Associate Professor of Sociology at the University of Georgia. She has recently co-authored a book, *The Social Contexts of Criminal Sentencing* (1987), with Susette M. Talarico.
