The contribution from Martin Hengel works out a historical overall view of the emergence and meaning of holy writings for Judaism at the time of the second temple. Other contributions deal with the reception of the Holy Scripture by Flavius Josephus in the *Paralipomena Jeremiae* as well as by Paul, John and in Hebrews. This volume concludes its researches by examining the use of writings by the Amoraes and into the phenomena of sacred writings from the view point of the academic study of religion.
