# Providing travel assistance for young WPSA members and students to participate in regional and global WPSA Conferences

The Association has funds set aside for a limited number of travel grants. These are to provide international travel assistance for YOUNG WPSA members (both scientists and poultry producers) from developing countries and STUDENTS from developed countries to attend and participate in regional and global WPSA conferences.

## **Application conditions**

- Applications must be submitted at least three months prior to the meeting. If a scientific paper or poster is the basis for the application, this need not have been accepted at the time of application but it will eventually must be formally accepted before funds are disbursed
- Maximum age of the applicant is 40 years at the time of application.
- Applicants must have been a member of WPSA for at least six months at the time of application.
- No member may receive more than two Travel Grants.
- Successful applicants will receive the funds electronically AFTER the meeting on receipt of a copy of the airline ticket.
- Incomplete or late submissions will NOT be considered.

Application form must be accompanied by:

Either

A copy of the submitted abstract.

Or

One typed page clearly outlining how you propose to network at the meeting. Describe the feasibility of your plan and what you hope to gain. Possibilities for the plan could include names of individuals you plan to interview or conference attendees you plan to meet who share similar interests to your own. Networking plans must be made in advance and must involve individuals with whom you are not already acquainted.

- Budget request and justification (one page). You must include the cost of economy rate travel, food and lodging. Conference registration fees and dues will NOT be funded.
- Letter of recommendation from a wellknown member of your WPSA Branch stating why you are a worthy candidate to receive a Travel Grant.
- 4. Short Curriculum Vitae and photo.

## WPSA Speakers Bureau Fostering local and regional conferences in the poultry sciences

During the 34th meeting of the Board of WPSA on August 20, 2000 in Montreal, Canada it was recognised that expertise in several areas of poultry science and production in low income countries is often very limited, and WPSA branches in these countries often do not have sufficient financial resources to fund overseas speakers.

To address this problem, the Board created a Speakers' Bureau to assist branches in low income countries to cover the travel costs of expert international speakers. This measure is consistent with the key objective of WPSA to encourage and facilitate liaison among research scientists and educators, and between those in research and education and those working in the many diverse sectors of the poultry industry. Under the Speakers' Bureau scheme, WPSA will pay only the cost of air travel (lowest economy class). All other expenses such as local travel and accommodation are to be paid by the organizing Branch(es). WPSA will not pay any honorarium to speakers.

Given the high cost of international air travel it is important that optimum value be obtained from this expenditure by WPSA. This can be achieved by insisting that the visiting speaker provides more than just one paper at a conference. The visiting speaker could contribute in a variety of ways, e.g., present a second paper on a related topic, conduct a workshop for graduate students, have small group or one-on-one interaction, especially with students, visit industry groups, visit university groups, etc.

Unless the Branch (or group of Branches) can pay all the speakers' costs itself, a speaker should NOT be invited until approval of Speakers' Bureau funds is made by the WPSA Executive Committee. The Branch(es) should not assume that approval will be given until so advised by the WPSA Secretary. Where a Branch or a group of Branches wish to apply for Speakers Bureau assistance, there are

certain conditions which must be met:

Application must be submitted at least 2 months prior to the meeting.

The speaker must contribute more to the meeting and/or branch than just presenting one paper.

Following approval, the speaker or the local Branch will be reimbursed by the WPSA Treasurer after the meeting.

A maximum of 2 speakers will be sponsored from the Speakers' Bureau per meeting. The Branch(es) must be up-to-date with their membership payment.

## Foundation for Promoting Poultry Science Stichting Bevordering Pluimveewetenschappen

The XIX World's Poultry Congress, held in September 1992 in Amsterdam, was financially successful. This outcome was, to a large extent, due to the contributions received from the 16 main sponsors and over 2500 participants. The terms of reference of the Congress Organizing Foundation required that any credit balance that resulted after all liabilities had been met should be made available to the Dutch Branch of WPSA as initiator of the organization of the Congress. As a result, a Foundation for Promoting Poultry Science (Stichting Bevordering Pluimveewetenschappen) was founded. The general objective of this foundation are "to promote the developments and propagation of poultry science in WPSA-structures, and specifically:

- 1. the stimulation of international congresses and the promotion of participation in these events, and
- the support of initiative having the objective of establishing WPSAbranches in countries which do not yet have them".

Individuals and organizations may apply for financial support for appropriate WPSA

activities such as conferences, congresses and symposia. Applications for financial support of conferences, congresses and symposia should be forwarded through the local WPSA Branch.

The Foundation has a particular interest in assisting in the process of establishing new WPSA branches and therefore supports these branches by covering for three years part of the membership fees. An application form will be send on request.

The Board of directors of the Foundation meets three or four times a year. In case of requests for financial assistance to attend conferences, congresses and symposia, applications should be received by the secretary at least 3 months before the meeting.

Application forms should be filled out completely and can be send through e-mail and fax. An original application form should be send by regular mail.

It is the Boards policy not to fund individual applicants more than 2 times.

## Scholarship Awards 2012

The Foundation for Promoting Poultry Science of the Netherlands Branch of the World's Poultry Science Association has announced that the fifth group of awards will be presented at the XXIV World's Poultry Congress in Salvador, Brazil in 2012. The awards are normally made in each of three categories - Education, Organization and Research - coinciding with the motto on the WPSA logo. An internationally representative committee chosen by the Board of the Foundation for Promoting Poultry Science will decide recipients. While it is anticipated that one award will be made in each category, this may vary depending on the number and quality of submissions.

## Research Award

A WPSA Research Award will be presented at each World's Poultry Congress to an outstanding scientist in recognition of research achievement related to the poultry industry. Only those who have been members of the World's Poultry Science Association for at least two years immediately preceding the Congress at which the award is made will be eligible. The award will consist of a suitably inscribed certificate or plaque and € 11 000 (currently about US\$ 14 500). The award will be made to a scientist who has made an

outstanding contribution in his or her field and will be based on up to five publications in refereed journals. The papers need not all relate to the same research project but they must be in the same general area. The scientist must be the senior author in the case of papers with multiple authors.

Nominations for the award may only be made by a WPSA member. Offprints or copies of the papers (up to five) on which it is based should accompany the nomination (other relevant papers may be cited). The nomination document, which should not exceed 1000 words, should include:

- reasons for making the nomination;
- a brief biography of the scientist being nominated:
- plans for the utilization of that part of the award not given directly to the recipient. These plans must be in sufficient detail to enable the awards Committee to assess the nature and value of the research programme. Examples of eligible costs include the purchase of leasing of equipment and stipends for graduate students.

## **Education Award**

A WPSA Education Award will be presented at each World's Poultry Congress to an individual

or group who, in the view of the Awards Committee, has/have made a major contribution to poultry management education in a five year period immediately preceding a World's Poultry Congress. Nominees (or leaders of groups in the case of joint nominations) must have been members of the World's Poultry Science Association for at least two years immediately preceding the Congress at which the award is made. The award will consists of a suitably inscribed certificate or plaque and € 11 000 (currently about US \$ 14 500).

Education will be interpreted liberally with achievement being represented by books, other publications, films, videos or the development of training programmes for poultry scientists, managers or workers. Nominations for the award may only be made by a WPSA member and should consist of:

- a description of the work, summarized in not more than 1000 words, which should give details of the educational project (including information on the target group or groups);
- an assessment of how much impact has been achieved;
- a clear indication of how the balance of the award would be applied to future educational activities. Examples might include publications, extension of courses, revision of videos etc., or entirely new initiatives.

The nominating document may be supported by additional items in the form of written or other work by the nominee/nominee group, but the nomination itself must be sufficient to standalone for evaluation by the Awards committee.

## Industry/Organization Award

A WPSA Industry/Organization Award will be presented at each World's Poultry Congress to an individual or organization who/which, in the view of the Awards Committee, has made an outstanding contribution to the development and/or success of the poultry industry in a five-year period immediately preceding a World's Poultry Congress. The development

of trade organizations, promotional or information programmes, or the invention of new processes or products relevant to the poultry industry will form the basis of the award. Nominees (or leaders of nominated organizations) must have been members of the World's Poultry Science Association for at least two years immediately preceding the Congress at which the award is made.

The award will consist of a suitably inscribed certificate or plaque and  $\in$  11 000 (currently about US\$ 14 500).

Nominations for the award may be made by any WPSA member and should consist of a citation in not more than 1000 words which includes:

- a description of the action or activity and how this has been of benefit to the poultry industry;
- an assessment of how much impact has been achieved;
- a clear indication of how the balance of the award would be applied to future activities, for example, new initiatives or the furtherance of the one which is the subject of the nomination.

The nominating document may be supported by additional written or other material, but must itself be sufficient to stand-alone for evaluation by the Awards Committee.

## **Nominations**

Nominations should be submitted to the WPSA Awards Committee at least six months before the start of the Salvador World's Poultry Congress. The deadline for receipt of submissions will be 31st December 2011. Please send nominations: c/o Dr R.W.A.W. To show how awards are utilized, those nominated must, if successful, undertake to present a report of their work at the next World's Poultry Congress following the one at which the award was made.

## Prof. Sally Solomon to Chair the Nominations Committee

The purpose of the Nominations Committee is to put forward the list of candidates for the positions of Secretary General, Treasurer and the five Vice-president positions to be voted for at the Council Meeting at each World's Poultry Congress (WPC). The membership and procedures to be followed by the Committee have been set out in the newlyadopted By-Laws of WPSA (see the WPSA website). The Committee is chaired by a WPSA member of high international repute appointed by the Board, and the Board is delighted to report that Prof Sally Solomon has accepted the invitation to act in this role. Sally is noted for her world-leading research on eggshell structure and quality. Other members

of the Committee will include the Immediate Past President of WPSA and the Immediate Past Presidents of the European and Asia Pacific Federations. The Committee will also co-opt other members to increase its geographic diversity so that the total membership of the Committee will be at least 15 but not more than 20.

The Committee will request nominations for all the above positions from branches. They may also receive proposals for candidates for nomination from individual WPSA members, submitted through the Secretary General at least 90 days before the date of the election at the WPC. For the positions of Secretary General and Treasurer, the Committee will

only nominate persons considered suitable for these positions in terms of experience and capability. For the Vice-presidential positions, the Committee will draw up a list of nominations that reflects the world-wide distribution of branches, with a minimum number of eight candidates. The Committee is obliged to confirm with all candidates their willingness to accept nomination and to communicate the list of nominees to the Secretary General at least 28 days before the date of the election.

The Board would like to thank Mr Cliff Nixey, who has been the chair of the Nominations Committee for the past two World Congresses.

## Asian Pacific Federation

A successful 9th APPC took place in March of this year. Over 700 delegates registered for the conference in Taipei, Taiwan. The conference was well organised by a dedicated team from the Taiwan Branch of WPSA, who must be congratulated for their efforts. Thanks also to the many sponsors, for without them it would be difficult to provide an event like this at such reasonable cost. In fact the registration fees set organising committee comparatively low, making the conference good value for the money. Keeping the cost of attendance down as low as possible is critical for future conferences, particularly in the Asia Pacific region. In this region many of our poultry industry people, researchers, teachers, managers, field service staff and farmers do not have the financial resources to attend high cost conferences. Lower cost conferences allow more people to attend, including many who otherwise might not, but will derive much value from attending such an event.

At the meeting of the Asian Pacific Federation, Korea was chosen as the host of the 10th APPC to be held in 2014. The venue will be the International Conference Centre on Jeju Island.

The Secretary/Treasurer for the Federation is not an elected post, it is chosen by the President. As such, Mr Don Thomas, New Zealand Branch will continue as Secretary/Treasurer (D.V.Thomas@massey.ac.nz).

Dr Jeng-Fang Huang, Taiwan Branch was elected as the inaugural chairman for the APF's Working Group 2 on Waterfowl (huangjf@mail.edu.tw).

A new working group for the APF was approved at the meeting. This is WG3 on Ratites and it will be chaired by Dr Irek Malecki from the Australian Branch (irek. malecki@uwa.edu.au).

Discussion is ongoing in relation to the APF's Working Group 1 Small Scale Family Poultry Farming. There has been a proposal that WG1 be formally merged with the International Network of Family Poultry Development (INFPD). INFPD is a global working group of WPSA. Talks were held between APF, FAO, IFAD and INFPD at the 7th International Poultry Show and Seminar in Dhaka, Bangladesh in late March. The outcome was an agreement to work more closely together in order to provide a truly global front. Achieving a formal merger is still a proposal and the dialogue continues. In the meantime, APF President Alan Gibbins will serve as the acting Chairman of WG1.

## WPSA Working Group 3 of Asian Pacific Federation

The Working Group 3 of the Asian Pacific Federation involves researchers working on 'Ratites' (emus, ostriches, rheas, cassowaries and kiwis).

Since the 3rd International Ratite Science Symposium that was held in Madrid (Spain) in 2005, the activity of the Working Group on Ratites gained momentum that culminated in a 3-day scientific conference, the 4th International Ratite Science Symposium that was held in 2008 during the 23rd World's Poultry Congress in Brisbane, Australia. Prior to that, a one-day Clean-Green-Ethical Ratite Farming Symposium was also held at the University of Western Australia, hosted by the UWA Institute of Agriculture. However, as the ratite industries worldwide have shrunk considerably, and support for ratite research has reduced, the activity of the Group slowed down and the European Federation of WPSA closed its Ratite Working Group 13. Even so, an interest in Ostrich farming continues in Europe with the most significant breeding stock thought to be held in Germany. In Germany, during the annual meeting of the German WPSA Branch a review on ostrich farming was presented by Mr Kistner and a visit to his Mhou farm was included in the programme. A great need for support from poultry scientists to improve management and acceptance of ostrich farming was expressed. Given that the majority of the ratite research

activity, however, is concentrated in the Southern Hemisphere the Ratite Group registered with the Asia Pacific Federation (APF) of WPSA as its new Working Group 3 (WG3). The membership of the WG3 of APF WPSA consists a good number of ratite researchers and veterinary practitioners from the North and South Americas, Europe, Africa, Central and East Asia, Australia and New Zealand who remained active and have continued their research in reproduction, genetics, incubation, nutrition, growth and development, health and welfare, conservation of ratites. Ratite researchers continue to publish in scientific journals and conference proceedings and the most recent output of the Group members is the publication of the book titled 'The Welfare of Farmed Ratites' (P. Glatz, C. Lunam, I. Malecki Eds., Springer-Verlag Heidelberg 2011).

The Ratite Group, plan to attend the 24th World Poultry Congresses 2012 in Brazil and the 10th Asia Pacific Federation Conference in South Korea. Membership in the APF WG3 and scientific meetings enquiries should be sent to Dr Irek Malecki.

## Argentina

Members of The Argentinean Branch of WPSA participating in several commissions of the Scientific Committee for the XXII Latin American Poultry Congress (www.avicultura2011.com). This meeting will take place in Buenos Aires, Argentina, on September 6-9, 2011. This extraordinary event will carry the slogan: 'Latin America: environmentally-friendly reservoir,' and it will be held at the premises of La Rural, the largest convention centre in the country. The WPSA will provide one expert speaker, supported by the 'WPSA Speakers programme. Dr Roel Mulder Bureau'

(Secretary General WPSA and Spelderholt® Poultry Consulting and Research) will present a lecture about 'European regulations for slaughter houses'.

The Latin American Poultry Conference will feature first-class conferences for an expected audience of 3500 attendants. Five conference rooms seating 1000, 600 and 400 persons will simultaneously present top international speakers who will provide new information on poultry Health, Nutrition, Farm Practices. Genetics and Incubation, Business Environment. Management, and the Conference participants will be able to choose between Spanish, Portuguese and English to follow the speakers.

The Poster area will cover more than 400 m2. Papers presented at the Congress will be included in a competition that will lead to several different prizes. As in all other Latin American Poultry Meetings, the papers accepted for the conference will take part in the Lauriston Von Schmidt Scientific Merit competition award. Mr Von Schmidt was one of the founders and Honorary President of the Latin American Poultry Association (ALA). On the other hand, beginning with the XXII Latin American Poultry Congress, all papers authored by research groups coming from two or more Latin American countries will take part in the Dr Arnaldo Colusi ALA competition award. Dr Arnaldo Colusi was a respected international scholar, professional and consultant in the poultry field.

#### Brazil

The Brazilian Branch of WPSA (WPSA-BR) is well underway on the organization of the XXIV WPC in 2012 in Salvador, BA, Brazil. The scientific committee has defined some tentative deadlines for abstracts and review papers submissions, which are:

The WPC's organizing committee just opened the convention centre's second floor area for specific groups, organizations, specialized media, and other companies interested in participating.

WPSA-BR was represented at VIV Bangkok Fair (Thailand) in March of this year by its President and Marketing Director who carried out some good promotional work for the 2012 WPC. The same promotional efforts will be carried out in Cancun (Mexico) at the XVII

Congress of the World Veterinary Poultry Association to be held on 14-18 August 2011.

The FACTA/WPSA-BR 2011 Annual Conference, which is the largest annual poultry scientific event in Latin America, will be held in Santos, SP, Brazil on the 31st of May through the 2nd of June. A total of 31 scientific presentations were given by poultry scientists and professionals from universities and industry in Brazil and several other countries. An estimated attendance of 1000 professionals was expected.

#### Cameroon

The Cameroon Branch of WPSA held its first General Assembly for 2011 on January 10, 2011 at 10:00 in the conference hall of the Faculty of Agronomy and Agricultural Sciences of the University of Dschang, Cameroon. The meeting was chaired by the branch's President, Prof. Alexis Teguia, assisted by the branch Secretary and Treasurer, Dr Jean Claude Fotsa and Dr Henri René Zambou, respectively. Half of the countries WPSA members attended the branch meeting during which the agenda with the following points was covered: Registration of members; General information, Membership's situation, financial report. Activity Report for 2010 and the Action plan for 2011.

Following the welcoming address by the branch President, new members were registered while old members paid their membership's fees. The branch now has a total of 37 members.

The main resolutions of the General Assembly were adopted as followed and included in the action plan for 2011: 1) The proceedings of the seminar held in Bafoussam on January 21, 2010 should be finalized and distributed to members. The resource persons who managed the seminar were thus invited to write and forward to the branch secretary a manuscript including an introduction, a brief summary of the presentation, a conclusion and the outcome of the seminar; 2) A typology study of poultry farms in Cameroon will be launched. Prof. Teguia and Prof. Tchoumboue were invited to propose a survey questionnaire to be dispatched to farmers by Dr Henry Zambou with the help

of other branch members; 3) The epidemiology map of Cameroon shall be considered as a priority. Dr Paul Tsangue was designated to propose the survey protocol for this study; 4) The National branch is to organize more seminars and conferences for the education of the members of the poultry sector; 5) Development of a summary of laws and regulation of livestock sector in Cameroon. Dr Poné Kamdem and Dr Zambou were designated for this important task; and, 6) A permanent contact with administrations acting for the rural development of Cameroon shall be developed and maintained.

#### Germany

The German Branch held its annual meeting in March at the University of Hohenheim. The board meeting was followed by a general meeting attended by 70 members and guests, a get-together in the evening and a conference on the following day, attended by about 100 participants. The six presentations covered a range of timely topics, focusing on nutrition and management to optimize economic returns and bird welfare. An update on molecular tools to monitor biodiversity and a short review on Ostrich Farming in Germany completed the program. After the conference, participants were invited to visit the Ostrich Farm Mhou of Mr Kistner in Rülzheim and to learn more about opportunities and limitations of ostrich farming. The German Branch confirmed its intention to submit a bid to host the World Poultry Congress 2020 in Berlin.

## Hungary

The 10th International Poultry Symposium was held on 6th April 2011 in Kaposvar, Hungary. It was organized by the University of Kaposvar in collaboration with the Hungarian Branch of the WPSA, and 130 registered participants attended the conference. Oral presentations were held with the following titles: New ways of periodical cooling during hatching; Improving the final live weight and growing ability of TETRA-H by using a new experimental Sire line; Changes in the body and egg composition of brown and Leghorn type layers; Problems behind switching from conventional cage to alternative systems for laying hens; The spontaneous fattening of

waterfowl liver; Heritability of different behaviour forms in the goose; Comparative analysis of the cardiovascular capacity of the bronze- and giant turkey with diagnostic imaging (MR, CT); and, the XIIIth European Poultry Conference (Tours, France, 2010) - An overview. Successful presentations were also provided by international specialists; Gérard Guy (INRA, France) and Prof. Dr Werner Bessei (University of Hohenheim, Germany).

## Japan

#### Association News

USA Branch has been suspended indefinitely in order to accumulate sufficient funds to support travel grants to the XXIV World's Poultry Congress, to be held on 5-8 August 2012, in Salvador, Bahia, Brazil.

A joint WPSA-USA/PSA bid for the 2020 World's Poultry Congress (WPC) in the US is being explored. If found feasible, a complete bid for the 2020 WPC will have to be prepared and finalized for presentation to the WPSA Board in December 2011. The vote for the WPC will take place during the 2012 WPC in Brazil.

A change in Section 7 of Article 10 of the PSA Constitution is proposed to streamline the continuity in the terms of the branch's officers.

This change, if approved by the membership, will call for the election of WPSA-USA Committee members every two years rather than every four years.

The procedure by which the WPSA Lecture speaker is selected by the WPSA-USA Committee and Canadian Branch of the WPSA will be revised. It basically places the identification and selection responsibility for the WPSA Lecture speaker back on the two branches, where it typically has been. The role of the PSA Board will be to make the final approval as it does for most symposia speakers.
