Dr Reynolds examines the social, cultural and political changes that accompanied the commercial evolution of the country. He takes his study of an exciting era through the period of peace and prosperity characterised by the rise of African merchants, the decline of traditional rulers, the impact of the Asante wars and the increase in European interests up to the threshold, a hundred years ago, of a truly modern economy.

Ghanaian-born Edward Reynolds is on the teaching staff of the Department of History, University of California.

Revolt in Bussa

A Study of British "Native Administration" in Nigerian Borgu, 1902-1935

In June, 1915, a force of six hundred warriors, armed mainly with bows and arrows, invaded Bussa in what was then the British Protectorate of Northern Nigeria and drove out the British-imposed Native Administration. *Revolt in Bussa* is a study of this rebellion and of the problems of the British in trying to administer peoples whose history and political organization they did not fully understand. Michael Crowder takes the rebellion as the central event in the history of British Native Administration or Indirect Rule in Bussa and provides an in-depth study of the problems of its operation at the grassroots level, highlighting the relationship between the African chiefs in Bussa and the British district officers.

Government and Politics in the Akuapem State, 1730-1850

The period of Akuapem's emergence was a time of great upheaval, mass movements of peoples, and the rise and fall of nation-states on the Gold Coast. Eventually these states became instrumental in the expansionist activities of the Netherlands, Denmark, and England. Akuapem, strategically located on one of the main trading routes to the coast, was thus involved in both the commercial rivalry of the Europeans and the Asante drive to open direct contact with the European forts. This is the first study of the internal and external factors which influenced the formation of the Akuapem state in the early 1700s and of the influences which affected its development over the following century.

LANSINÉ KABA Wahhabiyya

Islamic Reform and Politics in French West Africa

Between 1945 and 1958, a reform movement known as Wahhabiyya developed in Mali, and became an important element in the drive for independence. Challenging the traditional superstition and mysticism of Islam and dedicated to its purification, Wahhabiyya attracted the young traders, Quranic teachers, and nationalists, thus introducing a strong Islamic strain into the ideology of anticolonialism. As a member of the Manika trading group that provided the backbone of this movement, Lansiné Kaba is uniquely qualified for this study.

ABDUL HAMID M. EL-ZEIN The Sacred Meadows

A Structural Analysis of Religious Symbolism in an East African Town

In close contact with Southern Arabia since the beginning of the Islamic era, the East African coast has developed a fascinating blend of Arabic and Bantu religious cultures. The Sacred Meadows is an anthropological study of the religion of Lamu, an East African town of six thousand situated on an island belonging to Kenya, which lies below the Somali border. Professor Zein brings to his study of Islam in Lamu a sophistication in contemporary methods of structural analysis which enriches his understanding of life in this Moslem community.

MALINDI—the town on the Kenya coast which charmed Vasco da Gama with its Arabs in damasks and satins, rich agricultural produce and lofty buildings, and which today has become the most famous tourist resort of East Africa-is indeed an excellent subject for an historical geography of a Third World community.

The first part of this study concentrates on the economic geography of Malindi during the Portuguese, Zanzibar and British periods; the second on the conflicts between the traditionalists and the modernists which are analysed to show that most of the problems confronting Malindi's economy today have been engendered by conformity to age-old practices which do not answer Malindi's present needs.

They should not exceed about 6000 words (excluding footnotes), except with the prior approval of the Editors. A summary of the contents of the article, not exceeding about 300 words in length, should be attached on a separate sheet. Contributors are asked to observe closely the conventions listed in the Notes for Contributors, inside the back cover of Vol. XV, no. 1. It is essential that contributors observe these conventions, as the *Journal* now goes straight into page proof. This severely limits the number of corrections which are possible.

Page proofs will be sent, if necessary by airmail, to each contributor (or his nominee) provided that the Editors have been given an address through which he can be reached without delay. Corrections should be kept to the minimum, and should be corrections, not new material. If they are to be incorporated in the master proof corrected by the Editors, it is important that the contributor should return the page proofs, by airmail if necessary, to the Editor named when they are sent out (and *not* to the Cambridge University Press), within ten days of his receipt of them.

Contributors of articles and review articles receive 25 free separates. Additional separates may be obtained at reasonable cost, provided that they are ordered before publication on the special form sent out with the galley proofs.
