**Animals and Human Society:
Relationships, Exploitation and Imagination From Pre-History to the Present.**

The Davis Center theme for academic years 1996-98 will be "Animals and Human Society." We will explore the material, ethical and symbolic dimensions of the role of animals in human culture. The Center welcomes proposals for projects focussing on any of the following or related historical issues: animal gods, cults and sacrifice; sacred and 'unclean' animals; animals and war; the bestiary, mythical animals, beast fables, allegories, folklore, fairy tales; bestiality; the symbolic bestialization of enemies, races, ethnic groups, sexes, and occupations; animal trade (for example, furs and ivory); transhumance, domestication, farm animals and husbandry; ranching and pastoralism; animal products (wool, leather, parchment, bone for tools, horn for glue, etc.); diseases and epizootics; veterinary medicine; butchering, meat processing, and marketing; wild animals, 'savage' environments and the connections with aboriginal peoples; the artistic and photographic representation of animals in domestic and wild settings; children's literature and cartoons; pets; games and pleasures (horse racing, bear baiting, cock fighting); circuses and country fairs; vivisection, medical experimentation and animal welfare movements; vegetarianism and meat-eating; the boundaries between human beings and animals as expressed in different cultures; extinction of species; environmentalism; animal rights, Darwinianism, and modern efforts to define the human being; paleozoology (classification and origins of species).

The Center will offer a limited number of research fellowships for one or two semesters, running from September to January and from February to June, designed for highly recommended younger scholars who have finished their dissertations as well as for senior scholars with established reputations. Fellows are expected to live in Princeton in order to take an active part in the intellectual interchange with other members of the Seminar. Funds are limited, and candidates are, therefore, strongly urged to apply to other grant-giving institutions as well as the Center, if they wish to come for a full year.

- 5 Authors should submit the top copy of their typescript and keep another copy to assist in their correction of proofs.
- 6 Submission of an article is taken to imply that it has not previously been published, and is not being considered for publication elsewhere. Authors are also asked to provide brief details of any related article or book they are publishing elsewhere.
