The Harvard-Newcomen Postdoctoral Fellowship in Business History during the academic year 1980–81 is held by Daniel Pope, Assistant Professor of History, University of Oregon. Professor Pope earned his doctorate at Columbia University where his dissertation, on the early history of American advertising, was supervised by Stuart W. Bruchey. He is interested in the international activities of American advertising agencies.

The Harvard-Newcomen Postdoctoral Fellowship, sponsored by the Harvard Graduate School of Business Administration and the Newcomen Society in North America, is awarded annually "to assist young scholars who have, within the past ten years, received their Ph.D. in history, economics or a related discipline to improve their professional acquaintance with business and economic history, increase their skills as they relate to this field, and to engage in research that will benefit from the resources of the Harvard Business School and the Boston scholarly community." a small research travel fund is available. An additional allowance of \$1,200 per year is available to students with dependent children. These awards are renewable for one year beyond the initial year for students enrolled as M.A. candidates and for three years beyond the initial year for those pursuing the Ph.D. The deadline for application is February 7, 1981 for the academic year 1981-82.
