The Business History Conference now has a Home Page on the World Wide Web; the URL is http://cs.muohio.edu/BHC. The pages include information about the BHC, a membership directory, the call for papers for the 1996 meeting, information about the Conference's journal, Business and Economic History, and a membership sign-up form. The BHC pages arrived just in time to be included in the redesign of the Cliometrics Society Home Page and its transformation into "the Economic History Server" (URL: http://cs.muohio.edu), and the new bit-mapped buttons, including those for the BHC main page, were designed by the folks there. The individual BHC pages were designed and given HTML tags by Pat Denault; Will Hausman, the BHC's secretary-treasurer and editor of its journal, provided a good deal of information in electronic form; and Sam Williamson of the Cliometrics Society provided space on the Miami of Ohio server. University Publications of America has announced microfilm publication of the *Records of the National Negro Business League*. This publication will increase access to the only known set of the organization's conference proceedings for 1900–1919, plus its headquarters correspondence and business records from 1900 through 1923. Founded in 1900 and led by Booker T. Washington until his death in 1915, the League encouraged mutual support among African-American business and professional people. In time, it generated more specialized groups that affiliated with and reported to it. By 1914 these included national associations of bankers, funeral directors, the press, attorneys, insurance representatives, retail merchants, and real estate firms.

Part 1: Annual Conference Proceedings and Organizational Records, 1900–1919, filmed from the archives of Tuskegee University, on 3 reels with an accompanying printed guide, is \$355. Part 2: Correspondence and Business Records, 1900–1923, on 11 reels with a printed guide, is \$1,310.

The Department of History at the University of Delaware offers two- and four-year fellowships leading to an M.A. or Ph.D. degree for students interested in careers as college or university teachers or as public historians. The focus of the University of Delaware-Hagley Program is the history of industrialization, broadly defined, to include topics such as gender and technology; work and society; industrial architecture and design; and political economy. The Harvard Business School and the Newcomen Society of the United States announce a postdoctoral fellowship in business history to support twelve months of residence and research at the Harvard Business School for the academic year 1996–97. The stipend is \$44,000.

The purpose of this award is to enable scholars who have received the Ph.D. in history, economics, or a related discipline within the past ten years to improve their professional acquaintance with business and economic history, to increase their skills as they relate to this field, and to engage in research that will benefit from the resources of the Harvard Business School and the Boston scholarly community. The successful applicant will participate in the school's business history course, seminar, and case development activities. Those interested should request an application from Professor Thomas K. McCraw, Morgan 297, Harvard Business School, Boston, MA 02163. Completed applications for the 1996–97 Newcomen Fellowship must be received no later than 1 November 1995.

Harvard University announces the Alfred D. Chandler, Jr., Traveling Fellowships in Business History and Institutional Economic History. The grants will range from \$1,000 to \$3,000, with the funds awarded each year totaling approximately \$15,000. The purpose of the fellowships is to facilitate library and archival research in business history or in institutional economic history, broadly defined. Topics such as labor relations and government regulation would also be considered for awards, if the approach is primarily institutional. The intent of the awards is to encourage the kind of research exemplified by the published work of Alfred D. Chandler, Jr.

Three categories of applicants will be eligible for grants:

- Harvard University graduate students in history, economics, business administration, or a related discipline such as sociology, government, or law, whose research requires travel to distant archives or repositories;
- Graduate students or nontenured faculty in those fields from other North American universities, whose research requires travel to the Boston-Cambridge area (to study, for example, in the collections of the Baker, Widener, McKay, Law, Kress, or Houghton libraries);
- Harvard College undergraduates writing senior theses in these fields, whose research requires similar travel.

The fellowships will be administered by a committee of three faculty members from Harvard's Business School and History and Economics departments. The deadline for receipt of applications is 1 December 1995, and recipients may use their awards at any time during calendar 1996.
