THE COLLEGE'S MEDALS AND PRIZES

Attention is specially drawn to the Medals and Prizes which are offered annually by the College. The conditions of award are to be found in the *Membership List, 1977* or can be obtained from the Secretary.

Gaskell Medal and Prize

The examination for this prize is held in May of each year. In addition to a Medal the award attached to the prize is £75. The prize has always been considered one of the foremost academic distinctions obtainable in clinical psychiatry, and Members of the College are asked to bring it to the notice of suitable candidates who may be eligible to compete.

Entries must reach the Dean not later than 31 March in each year.

Bronze Medal and Prize

This prize is awarded annually for the best Dissertation submitted under conditions printed in the *Membership List* or obtainable from the Secretary. Candidates are reminded that Dissertations must reach the Dean before 30 April in each year, and must not exceed 10,000 words in length.

Divisional Prizes

Papers certified as eligible for this competition must be forwarded to reach the Dean not later than than 20 April in each year.
