Bradley Chapin provides a quantitative breakdown of the sources of American law, a statistical analysis of crime in the colonies, and a review of the Quaker and witchcraft trials in New England. Addressing the much-debated question of colonial reception of English law, Chapin argues that reform succeeded in the new world while it failed in the old, that the colonists planted old seeds in new fields and brought forth a better harvest. \$18.00
