She specializes in Prussian and Spanish history, with a focus on the history of emotions, questions of gender, nationalism, and religion. Her publications include “*Treue Freunde*”...? *Westdeutschland und Spanien 1945–1963* (1999); *Preußens Ruhm und Deutschlands Ehre: Zum nationalen Ehrdiskurs im Vorfeld der preußisch-französischen Kriege des 19. She is the editor of *Gefühl und Kalkül: Der Einfluss von Emotionen auf die Politik des 19. und 20. DEBORAH BARTON is assistant professor of modern German and European history at the University of Montreal (Department of History, 3150 Jean-Brillant, Montreal QC, H3T 1N8 Canada; email: deborah.barton@umontreal.ca.). She has published on the topics of journalism and gender during World War II on the Eastern front, and on women journalist’s entanglements in Cold War politics. She is currently completing a monograph based on her doctoral dissertation, which examines the role and influence of German women journalists in the Nazi and postwar press.

DAVID BLACKBOURN is the Cornelius Vanderbilt Distinguished Chair and Professor of History at Vanderbilt University (Department of History, Vanderbilt University, 2301 Vanderbilt Place, PMB 351802, Nashville, TN 37235; email: david.blackbourn@vanderbilt.edu). His books cover a wide range of subjects in the field of German history since the eighteenth century, and include *The Peculiarities of German History: Bourgeois Society and Politics in Nineteenth-century Germany* (with Geoff Eley, 1984); *Marpingen: Apparitions of the Virgin Mary in Nineteenth-century Germany* (1993); *The Long Nineteenth Century: A History of Germany, 1780–1914* (1998); *The Conquest of Nature: Water, Landscape and the Making of Modern Germany* (2006); *Landschaften der deutschen Geschichte: Aufsätze zum 19. und 20. Jahrhundert* (2016). Currently he is working on a book titled “Germany in the World, 1500–2000.”

JAMES M. BROPHY is the Francis H. Squire Professor of Modern European History at the University of Delaware (Department of History, University of Delaware, 236 John Munroe Hall, Newark, DE 19716; email: jbrophy@udel.edu). He specializes in modern European history, particularly the social and political history of nineteenth-century Germany, and has published *Capitalism, Politics, and Railroads in Prussia, 1830–1870* (1998) and *Popular Culture and the Public Sphere in the Rhineland, 1800–1850* (2007); he also coedited *Perspectives from the Past: Sources in Western Civilization* (6th ed., 2016). In addition, he has published numerous essays on the social, economic, and political history of nineteenth-century Germany and Europe. Brophy is currently working on the book manuscript “Print Markets and Political Dissent:

Publishers in Central Europe, 1800–1870,” which examines the role of Central Europe’s leading publishers as cultural brokers and political actors.

ALEX CHASE-LEVENSON is assistant professor of history at the University of Pennsylvania (Department of History, Pennsylvania, College Hall 208, Philadelphia, PA 19104; email: alchase@sas.upenn.edu). He specializes in modern British, European, and Mediterranean history, and is currently completing a book that investigates nineteenth-century Britain’s engagement with the Mediterranean quarantine system. Other research interests include the history of borders around the British imperial world; the history of museums, archaeology, and theater; and the history of relations between Britain and continental Europe in the era preceding World War I.

ROGER CHICKERING is professor emeritus of history at Georgetown University (7718 SW Surfland St., South Beach, OR 97366; email: chickerr@georgetown.edu). He has published works on German and European history that emphasize questions of historiography, war, and peace. His publications include *Imperial Germany and a World Without War* (1975); *We Men Who Feel Most German* (1984); *Karl Lamprecht: A German Academic Life (1856–1915)* (1993); *Imperial Germany and the Great War, 1914–1918* (1998, 3d ed., 2014); *The Great War and Urban Life in Germany: Freiburg, 1914–1918* (2007).

SEBASTIAN CONRAD is professor of history at the Free University of Berlin (Friedrich-Meinecke-Institut, Freie Universität Berlin, Koserstraße 20, 14195 Berlin, Germany; email: sebastian.conrad@fu-berlin.de). He has a background in both modern Western European and Japanese history, and he has worked extensively on issues of colonialism and postcolonialism, transnationalism, intellectual history, memory, and historiography. He is currently interested primarily in transnational and global history approaches, and their contribution to an understanding of the interactions and entanglements of the past. Recent publications include *What is Global History?* (2016); *German Colonialism: A Short History* (2012); *Globalisation and the Nation in Imperial Germany* (2010); *The Quest for the Lost Nation: Writing History in Germany and Japan in the American Century* (2010). Together with Jürgen Osterhammel, he has coedited *History of the World: An Emerging Modern World, 1750–1870* (2018).

ALYS X. GEORGE is assistant professor of German and affiliate faculty of the Center for European and Mediterranean Studies at New York University (Department of German, 19 University Place, New York, NY 10003; e-mail: alys.george@nyu.edu). Her research and teaching focus on the cultural history, literature, and visual culture of Austria and Germany. Her book, *The Naked Truth: Viennese Modernism and the Body*, is forthcoming with an academic press.

KAREN HAGEMANN is James G. Kenan Distinguished Professor of History and adjunct professor of the Curriculum in Peace, War and Defense at the University of North Carolina at Chapel Hill (Department of History, University of North Carolina, CB #3195, Chapel Hill, NC 27599; email: hagemann@unc.edu). She has published widely in modern German, European, and transatlantic history, the history of military and war, as well as women’s and gender history. Her most

recent monograph is *Revisiting Prussia's Wars Against Napoleon: History, Culture and Memory* (2015), and her most recent edited volumes are *War, Demobilization and Memory: The Legacy of War in the Era of Atlantic Revolutions* (with Alan Forrest and Michael Rowe, 2016); *The Oxford Handbook of Gender and War since 1600* (general editor, with Stefan Dudink and Sonya O. Rose, 2019). Currently she is working on *Die vergessenen Soldatinnen: Frauen, Militär und Krieg*, a book that will also be published in English translation.

PETER HAYES is professor of history and German and Theodore Zev Weiss Holocaust Educational Foundation Professor of Holocaust Studies Emeritus at Northwestern University (Department of History, 1881 Sheridan Road, Northwestern University, Evanston, IL 60208; email: p-hayes@northwestern.edu). His publications include *Industry and Ideology: IG Farben in the Nazi Era* (1987, 2001), which won the Hans Rosenberg Prize of the Central European History Society in 1988; *From Cooperation to Complicity: Degussa in the Third Reich* (2004); *The Oxford Handbook of Holocaust Studies* (coedited with John K. Roth, 2010); *How Was It Possible? A Holocaust Reader* (2015); *Why? Explaining the Holocaust* (2017); *German Railroads/Jewish Souls: The Reichsbahn, Bureaucracy, and the Final Solution* (coedited with Christopher Browning, 2019).

PIETER M. JUDSON is professor and chair of the Department of History and Civilization at the European University Institute in Florence (Department of History, European University Institute, Villa Salviati, Via Bolognese 156, 50139 Florence, Italy; email: pieter.judson@eui.eu). He was previously Isaac H. Clothier Professor of History and International Relations at Swarthmore College. Judson's research focuses on the Habsburg Monarchy in the nineteenth century. In addition to coediting *Constructing Nationalities in East Central Europe* (2005), he is the author of *Exclusive Revolutionaries: Liberal Politics, Social Experience, and National Identity in the Austrian Empire 1848–1914* (1996); *Wien Brennt. Die Revolution 1848 und ihr liberales Erbe* (1998); *Guardians of the Nation: Activists on the Language Frontiers of Imperial Austria* (2006); *The Habsburg Empire: A New History* (2016), which appeared in German as *Habsburg: Geschichte eines Imperiums 1740–1918* (2017). Judson is currently coediting the second volume of the *Cambridge History of the Habsburg Monarchy, 1790–1918*.

LLOYD S. KRAMER is a professor of history at the University of North Carolina at Chapel Hill and the director of Carolina Public Humanities, an outreach program that organizes programs on the humanities for public audiences and teachers throughout North Carolina (Department of History, The University of North Carolina at Chapel Hill, 455 Hamilton Hall, CB# 3195, Chapel Hill, NC 27599; email: lkramer@unc.edu). His research interests focus on modern European history, with an emphasis on nineteenth-century France. He is particularly interested in historical processes that shape cultural identities, including the experiences of cross-cultural exchange and the emergence of modern nationalism. His publications include *Lafayette in Two Worlds: Public Cultures and Personal Identities in an Age of Revolutions* (1996); *Nationalism: Political Cultures in Europe and America, 1775–1865* (2011); and, with R. R. Palmer and Joel Colton, *A History of Europe in the Modern World*, 11th edition (2014).

SIMONE LÄSSIG is director of the German Historical Institute Washington, D.C. (1607 New Hampshire Ave., Washington, D.C. 20009; email: prolaessig@ghi-dc.org), professor of modern and contemporary history at the University Braunschweig, and director of the Georg Eckert Institute for International Textbook Research (currently on leave). As a social and cultural historian of modern Germany and Europe and a scholar of digital history, she has published on a broad variety of topics, with a focus on German-Jewish history and the history of knowledge, as well as on educational media research. Her most recent monograph is *Jüdische Wege ins Bürgertum: Kulturelles Kapital und sozialer Aufstieg im 19. Jahrhundert* (2004), and her coedited works include *Biography between Structure and Agency: Central European Lives in International Historiography* (with Volker Berghahn, 2008); *Space and Spaciality in Modern German-Jewish History* (with Miriam Rürup, 2016); “Knowledge and Migration,” a special issue of *Geschichte und Gesellschaft* (with Swen Steinberg, 2017).

SUZANNE MARCHAND is Louisiana State University Systems Boyd (University) Professor of European Intellectual History at Louisiana State University, Baton Rouge (Department of History, Louisiana State University at Baton Rouge, Baton Rouge, Louisiana, 70803; email: smarch1@lsu.edu). She is interested in the history of the humanities, especially classical studies, art history, anthropology, history, and theology in modern Europe. Her publications include *Down from Olympus: Archaeology and Philhellenism in Germany, 1750–1870* (1996) and *German Orientalism in the Age of Empire: Race, Religion, and Scholarship* (2009). She is also the coauthor of two textbooks: *Worlds Together, Worlds Apart* (5th ed., 2017) and *Many Europes* (2013). Marchand is currently writing a book about the history of the porcelain industry in Central Europe, and another book about the reception of Herodotus from 1700 to the present.

ALEXANDER M. MARTIN is professor of Russian history at the University of Notre Dame (Department of History, University of Notre Dame, 219 O’Shaughnessy Hall, Notre Dame, IN 46556; email: a.m.martin@nd.edu). His research interests include Russia from the mid-eighteenth to the late nineteenth centuries, as well as European history in the “long” nineteenth century, especially political, intellectual, social, and urban history. He is the author of *Romantics, Reformers, Reactionaries: Russian Conservative Thought and Politics in the Reign of Alexander I* (1997) and *Enlightened Metropolis: Constructing Imperial Moscow, 1762–1855* (2013). JÜRGEN OSTERHAMMEL is professor emeritus of modern and contemporary history at the University of Konstanz (Ziegelweg 36, D-79100 Freiburg im Breisgau, Germany; email: juergen.osterhammel@uni-konstanz.de). His publications in English include *Colonialism: A Theoretical Overview* (1997); *Globalization: A Short History* (coauthored with Niels P. Petersson, 2005); *The Transformation of the World: A Global History of the Nineteenth Century* (2014); *Decolonization: A Short History* (coauthored with Jan C. Jansen, 2017); *Unfabling the East: The Enlightenment’s Encounter with Asia* (2018). Since 2012, he is the coeditor with Akira Iriye of a six-volume *History of the World*. Central European History publishes articles, review essays, and book reviews that range widely through the history of Germany, Austria, and other German-speaking regions of Central Europe from the medieval era to the present. All topics and approaches to history are welcome: cultural, social, political, diplomatic, intellectual, economic, and military history, as well as historiography and methodology. Contributions that treat new fields, such as post-1945 and post-1989 history, maturing fields such as gender history, and less-represented fields such as medieval history and the history of the Habsburg lands are especially desired. The journal thus aims to be the primary venue for scholarly exchange and debate among scholars of the history of Central Europe. Because space is limited, articles that have been or soon will be published elsewhere are not accepted. Manuscripts submitted to CEH should not be under consideration by another journal pending decision of the editor on publication. If it is learned that an article is under submission to another journal while being considered at CEH, consideration will cease immediately. Unsolicited book reviews are not accepted.
