**THE SUPERANNUATION OF OFFICERS IN
HOSPITALS FOR THE INSANE: Its Principle, Policy, and Practice.**

By **W. LAUDER LINDSAY, M.D., F.R.S.E.**, Physician to the Murray Royal
Institution (for the Insane), Perth.

"This little book . . . might seem from its title to be merely a plea on behalf of Asylum Officers; but it is in reality a most important contribution to the welfare of the Insane. Every Asylum Superintendent knows too well how important and how difficult it is to secure and to retain good Attendants. The standard required is so high, the duties are so trying, and the drawbacks are so numerous that the difficulty is not to be wondered at. Yet good Attendants are quite indispensable to the efficiency of an Asylum, and the welfare of its inmates. Dr. Lindsay casts no slur on human nature when he expresses the opinion that good Attendants cannot be got or retained unless the immediate Remuneration be ample, and a Pension assured. He thinks—and we entirely agree with him—that the right to a liberal Pension after 15 years' good service would do more than anything else to attain this end. The Pension, in Dr. Lindsay's opinion—and we again agree with him—should be two-thirds of the total yearly value of the office, with smaller or temporary Pensions for shorter service; but a most just and proper distinction is drawn between those officials who have the constant wearing anxiety inseparable from the direct care of patients, and those who are engaged in the administrative or economic departments, and have no such unceasing responsibility. Very elaborate and carefully compiled Tables are given, showing the present practice as to Superannuation in the Asylums of Great Britain. It is certainly strange that Pensions have so rarely been held forward to attract good servants, while the principle of granting them has been so generally recognised. Dr. Lindsay has done well to point this out so forcibly. The size of the book is quite deceptive: for it represents an enormous amount of trouble and correspondence. It is a very able, exhaustive and valuable Summary of the whole subject of Asylum Superannuation: and Dr. Lindsay deserves the cordial thanks of his fellow workers, and of all interested in the welfare of the Insane, for this Labour of Love."—*Dr. Yellowless, Physician to the Glasgow Royal Asylum.*
