1. Original Articles are accepted on the condition that they have not been published elsewhere.

2. Manuscripts should be typewritten, on one side only of the paper, and well spaced.

The Harvard system of recording references should be used, e.g. GREEN, C., and BROWN, D. (1951) *J. Laryng. and Otol.*, 65, 33.

It is most important that authors should verify *personally* the accuracy of every reference before submitting a paper for publication.

3. Galley proofs and engraver's proofs of illustrations are sent to the author. Corrections, which should be kept to a minimum, must be clearly marked, and no additional matter added.

4. The *Journal* bears the cost of illustration blocks up to the value of £2 for each article, but any expense above this will have to be borne by the author.

5. Orders for reprints should be sent when returning galley proofs, and for this purpose special forms are supplied.

6. Authors of original communications on Oto-Laryngology in other journals are invited to send a copy, or two reprints, to the *Journal of Laryngology*. If they are willing, at the same time, to submit their own abstract (in English, French, Italian, or German) it will be welcomed.

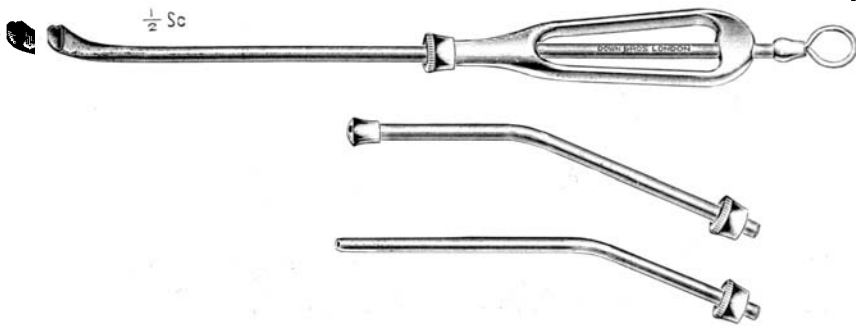

## A NEW SUCTION INSTRUMENT

Apart from light, the next most important physical aid to those Surgeons doing Ear, Nose, and Throat, work, is adequate suction.

For this purpose a useful universal handle with several interchangeable suction tubes for various operations has been manufactured for me by Messrs. Down Bros. and Mayer & Phelps Ltd. of London.

The suction set consists of:

A universal handle to which can be adapted—

- (a) A Yankauer suction tube.
- (b) A Tonsil suction dissector.
- (c) An angled all purpose suction tube.

The instruments are of stainless steel and provided with a stillette, the joints are "screw on" and airtight.

The Yankauer tube is accurately reproduced in a lighter and smaller size and gives equally satisfactory suction. It is ideally suited for operations on children and for atraumatic nasal suction in all cases.

The tip of the Tonsil suction dissector is curved similar to the popular Hurd tonsil dissector, the suction is on the concave side, and the edge is slightly serrated to give easier, yet atraumatic dissection.

This dissector has been used in about 2,000 Tonsillectomies, and gives a dry field dissection in even the "beefiest" of Tonsils. The resident Surgeons seem to take to it quickly.

The design of the handle and Tonsil dissector is a lighter and smaller reproduction of Popper's original one piece dissector.

The angled smooth suction tube has a universal application.
