According to the French historian Michelet, Russia, before the publication of August von Haxthausen's *Studies on the Interior of Russia*, had been "scarcely better known than America before Columbus." Professor Starr's English edition contains the heart of the masterful three-volume narrative. Among the highlights are descriptions of village life in central Russia, discussions of sectarian communities, analyses of colonization, and essays on Moscow, the nobility, the religiosity of Russia, and the peasant commune.

Using a wide range of sources, Professor Pomper traces the history of Lavrov's revolutionary pursuits. He studies Lavrov as radical émigré publicist, editor of *Vpered!*, prophet of the preparationist strategy of the early 1870s, and details his involvement in the strategic debates and innovations between the mid-1870s and 1900. Professor Pomper analyzes the dynamic relationship between Lavrov's personality, his philosophy, and his affiliation with revolutionary socialism.
