CONTRIBUTORS

Matthew Butler is Associate Professor of Mexican History at the University of Texas at Austin and researches the religious and agrarian history of nineteenth- and twentieth-century Mexico. His most recent publication, co-edited with Yves Solís and Camille Foulard, is *Cruce de fronteras: la influencia de los Estados Unidos y América Latina en los proyectos de nación católicos en México, siglo XX* (2020). A recently completed manuscript on the history of revolutionary-indigenous Catholicism in Mexico, *Father Pérez's Revolution: The Mexican Catholic and Apostolic Church*, is under review. He is finishing another manuscript on the history of Catholic dissent in Mexico and a co-edited volume on the history of indigenous land privatizations in nineteenth-century Michoacán.

Luis Herrán Ávila is Assistant Professor of History and Latin American Studies at the University of New Mexico. He has published in both English and Spanish on various aspects of Latin American Cold War history with a focus on right-wing movements and is currently working on a manuscript about the transnational dimensions of Mexican Cold War anticommunism. He received his PhD in Politics and Historical Studies from the New School for Social Research in 2017.

Jorge Puma is a PhD candidate in History at the University of Notre Dame and the University of Paris-Saclay. He is a Kellogg Institute PhD Fellow and a Fulbright-García Robles 2017 alumnus. His dissertation project deals with the reception of left-wing ideologies in late twentieth-century Mexico in the context of social and political changes on a global scale. In 2021, the project won an award for historical research dissertation projects from the National Institute for the Historical Studies of Mexico's Revolutions (INEHRM). His research focuses on a transnational community of revolutionaries and student radicals who adopted Maoism, and their interaction with Catholic activism inspired by the Second Vatican Council. Puma has published his work in peer-reviewed journals in Chile and United States. His latest work, on Mexican Maoism, appeared in the November 2017 *Latin American Perspectives*.

Julia Young is a historian of migration, Mexico and Latin America, and Catholicism in the Americas at The Catholic University of America in Washington, DC. She is the author of *Mexican Exodus: Emigrants, Exiles, and Refugees of the Cristero War* (2015) and the co-editor of *Local Church, Global Church: Catholic Activism*

in *Latin America from Rerum Novarum to Vatican II* (2015). She has published scholarly articles in *The Americas*, *Catholic Historical Review*, *Mexican Studies/Estudios Mexicanos*, *Modernism*, and the *Journal on Migration and Human Security*. In 2020-21, she was a fellow at the Luce/ACLS Program in Religion, Journalism & International Affairs. She frequently writes for the media about immigration, border issues, and Catholic immigration history.

Gema Kloppe-Santamaría is Assistant Professor of Latin American History at Loyola University Chicago and a 2021-22 Marie Curie Junior Fellow at the Freiburg Institute of Advanced Studies. Her research deals with questions of violence, gender, religion, and state formation in Latin America. She is the author of *In the Vortex of Violence: Lynching, Extralegal Justice, and the State in Post-Revolutionary Mexico* (2020). Her work has been featured in several academic journals including *Latin American Research Review*, *Journal of Latin American Studies*, *Journal of Social History*, *The Americas*, and the *Oxford Encyclopedia of Latin American History*. Her research has been supported by a number of grants, including most recently a 2020 Harry Frank Guggenheim Foundation Distinguished Scholar Award and a 2021 Mellon Emerging Faculty Leaders Award. She is currently working on a second book project on the contentious relationship between religion and violence in twentieth-century Mexico.

Jaime M. Pensado is Associate Professor of History at the University of Notre Dame. He is the author of *Rebel Mexico: Student Unrest and Authoritarian Political Culture During the Long Sixties* (2013) and co-author with Enrique C. Ochoa of *México Beyond 1968: Revolutionaries, Radicals, and Repression during the Global Sixties and Subversive Seventies* (2018).
