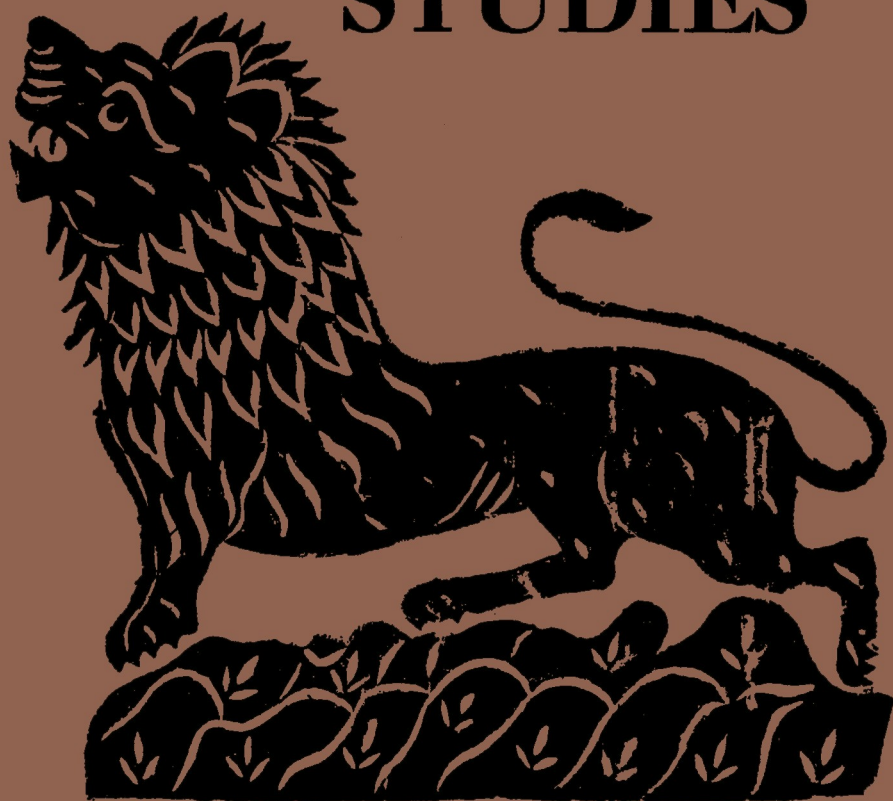

CONTRIBUTORS TO THIS ISSUE

Josef L. Altholz, Associate Professor of History in the University of Minnesota, is the author of *The Liberal Catholic Movement in England*. He is now on a Guggenheim Fellowship, preparing a book on "The Churches in the Nineteenth Century."

Joseph O. Baylen is Professor of History and Chairman of the Department of History at the University of Mississippi. He was Fulbright Lecturer in the University College of Wales, 1961-62, is the author of a monograph, *Mme. Juliette Adam, Gambetta, and the Idea of a Franco-Russian Alliance*, and has completed for publication a biography of W. T. Stead.

Walter F. Cannon is Curator in Charge, Division of Physical Sciences, in the Museum of History and Technology, Smithsonian Institution. He was on a National Science Foundation Grant for study in London during 1962-63, and is the author of articles on early Victorian science.

R. J. Kaufmann, Professor of History and English at the University of Rochester, is the author of *Richard Brome, Caroline playwright* and the editor of and contributor to *Elizabethan Drama; Modern Essays in Criticism*. He is now spending a sabbatical leave on a Guggenheim Fellowship in England and Italy, preparing a book on twentieth-century British intellectual history.

Robert Kelley, Associate Professor of History at the University of California, Santa Barbara, is the author of *Gold vs. Grain: the Hydraulic Mining Controversy in California's Sacramento Valley*, and of articles on British and American history in the nineteenth and twentieth centuries.

Francis Oakley, Assistant Professor of History at Williams College, is publishing *The Political Thought of Pierre d'Ailly; a Study in the Voluntarist Tradition* and is the author of articles in the *Journal of British Studies* and the *Harvard Theological Review*.

William L. Sachse is Professor of History at the University of Wisconsin and was Chairman of the Department of History, 1958-61. He is the author of *The Colonial American in Britain*, and the editor of *The Diurnal of Thomas Rugg, 1659-1661*.

Neal Wood, Associate Professor of Political Science at the University of California, Los Angeles, is the author of *Communism and British Intellectuals*, and is working on a study of Machiavelli's social and political thought.
