## Subscriptions

*New Testament Studies* (ISSN 0028-6885) is published four times a year in January, April, July and October. Four parts form a volume. The subscription price, which includes delivery by air where appropriate plus electronic access to institutional subscribers (but excluding VAT), of volume 68 is £294 (US \$504 in USA, Canada and Mexico) for institutions and £80 (US \$130 in USA, Canada and Mexico) for individuals. Students may subscribe at £31 (US \$53 in the USA, Canada and Mexico). Single parts are £82 net (US \$139 in USA, Canada and Mexico) plus postage.
