America Adopts the Automobile, 1895–1910

by James J. Flink

Between 1895 and the late 1920's American civilization was transformed by the automobile and the automobile industry. In *America Adopts the Automobile, 1895–1910*, James J. Flink writes about the formation of an American automobile culture during the period from the introduction of the motor vehicle into the United States in 1895 to the opening of the Ford Motor Company's Highland Park plant on January 1, 1910. He concludes that Americans by 1910 were committed to automobility and that, with the development of a mass market for motorcars, the automobile industry in America had reached a critical turning point. From then on, the automobile and the automobile industry "called the tune and set the tempo of modern American life."

In contrast to earlier historians of the automobile, Professor Flink avoids narrow concentration on the automobile industry and its product. He focuses instead on the automobile as a factor influencing and influenced by American civilization. The molding of a favorable public opinion of the automobile by the press, the growth of automobile clubs, the evolution of legislation intended to regulate the motor vehicle, the development of roads and services for the motorist, and regional, class, and occupational differences in automotive innovativeness—these are some of the topics that are dealt with adequately for the first time in this authoritative volume. Forty-six full page illustrations augment the text.

The First Henry Ford:

A Study in Personality and Business Leadership

by Anne Jardim

In this book Anne Jardim traces the progression from success to failure by cautiously and rigorously examining the personality of Henry Ford. "It was Henry Ford who shaped the company," Miss Jardim remarks, "and it is surely valid to examine what shaped Henry Ford." She notes the crucial influence of conflicts in Ford's early history on his style of business leadership, on the precipitation, definition, and attempted resolution of the problems facing his company. The issue of individual personality in business leadership is implicit in the unanswered questions of Ford's biographers and company historians, and in the incomplete evaluations reached by organizational theorists on the structure and functioning of the Ford Motor Company: Why as a self-proclaimed advocate of progress did Ford persist in standardized production of the Model T and refuse to make any fundamental improvement in the car long after its market appeal faded? Why did he "change" from a capable mechanic who commanded the loyalty and best efforts of his subordinates to a vindictive, arrogant, and deeply suspicious man surrounded by "yes" men who bent reality to the Ford model? And what did the Model T symbolize for Ford? The book makes sense of such puzzling shifts and inconsistent behavior in Ford's turbulent career.

Two Newcomen Awards in Business History are offered annually for articles published in the *Business History Review*. The *First Prize*, of \$250, is awarded the article judged, according to the rules outlined below, to be the best of the year. The *Special Award*, of \$100, is for the best article by an author who is not more than 35 years of age and who has not published a book.

Prize articles are selected by a panel of judges composed of a representative of The Newcomen Society and members of the Advisory Board of the *Business History Review*. No member of the Advisory Board or editorial staff shall be eligible for a prize, and articles so authorized will not be considered in the judging. Authors eligible for the *Special Award* shall also be eligible for the *First Prize*, but in no event shall both prizes be awarded for the same article. The Advisory Board reserves the right to withhold the *Special Award* in the event that eligible articles do not, in the Board's judgment, merit prize consideration. The awards program is administered by the editorial offices of the magazine.

Criteria for selection include: originality, value, breadth, and interest of contribution, quality of research materials and methods, and quality of presentation.
