Carlos Reis studied at the University of Coimbra where he has served as full Professor in the Department of Romance Philology since 1990. He is a leading authority on Portuguese literature and especially Eça de Queirós, being the general editor of the standard modern critical edition of which six volumes have already appeared. He is also general editor of the *História crítica da literatura portuguesa* (five volumes to date). He was awarded the Jacinto do Prado Coelho Prize by the Portuguese section of the International Association of Literary Critics (1996) and was elected president of the Associação Internacional de Lusitanistas for 1999–2002. Louis Cohen Van Delft known as **Van Delft**, who was born in 1938, is emeritus professor of French language and literature at the University of Paris X. He holds the *agrégation* in modern literature, a *doctorat 3e cycle* and a *doctorat d'Etat*, and has also taught at Yale and McGill (Montreal) universities. He has been invited Professor at the universities of Harvard, Düsseldorf, Eichstätt, Pisa, Jerusalem, Tel-Aviv (Bar-Ilan) and Princeton, and has worked on secondment or visiting in Cameroun, Canada, Germany and USA. His principal areas of expertise are the classical period and contemporary theatre. David A. Wells has served as Secretary-General of the FILLM since 1981. He has also for many years been active in the Modern Humanities Research Association, as Honorary Secretary 1969–2001, and now as Honorary Treasurer, and it was through the historically close involvement of the MHRA in the FILLM that he became drawn into the management of the latter. He has held academic posts at the University of Southampton, Bedford College (University of London), and The Queen's University of Belfast, and since 1987 has been a Professor in the School of Languages, Linguistics and Culture at Birkbeck College (University of London), an institution which for its undergraduate degree courses specializes in part-time face-to-face teaching of mature students who attend classes in the evenings. Professor Wells is trained as a medieval Germanist and has published monographs and articles on a range of topics, in particular on the 12th-century corpus of German religious poetry, early

medieval didactic poetry and religious polemical dialogue, and their assimilation by poets of the classical Middle High German period.
