A Matter Of Principle RONALD DWORKIN

Ronald Dworkin's powerful new book explores that 'grey area' of our political consciousness between practical problems and matters of principle. The controversies it joins are old but recent events have given them fresh shape. For example, the deployment of nuclear missiles has had a powerful impact on people's attitudes about civil disobedience, and more generally about

the connection between conscience and political obligation. With his usual forceful style Ronald Dworkin addresses questions about the Anglo-American legal system as protector of individual rights and as machinery for furthering the common good. He discusses whether judges should make political decisions in hard cases, the balancing of individual rights versus the good of the community, whether a person has the right to do what society regards as wrong, and helps us thread our way through such timely issues as the rights of the press and pornography.

One of the book's main messages is a strong caution: if we care so little for principle that we dress policy in its colours when it suits us, then we cheapen principle and diminish its authority.
