# CHAPTER II

# TWENTY NINTH GENERAL ASSEMBLY BUSINESS SESSIONS

#### FIRST SESSION: Tuesday, 4th August 2015, 16:00-18:00

Chaired by Norio Kaifu, President of the IAU Hawai'i Convention Center, Honolulu, HI

- the National Representatives for Membership Nominations, in they capacity to discuss and vote on individual membership issues, as well as to propose nominations and elect the Special Nominating Committee (SNC), and the Membership Committee.

For each National Member, the first line gives the names of the Representatives present during the first week of the GA, the second line, if present, gives the names of the Representatives present during the second week of the GA.
