### Section Chairs Welcome Proposals for 1985 Annual Meeting

Richard F. Fenno, Jr., president-elect of APSA, has appointed Joseph Cooper, Dean of the School of Social Sciences at Rice University, to chair the Program Committee for the 1985 Annual Meeting. In addition, scholars have been named to head the 23 sections planned for next year's program. These nominations were approved by the Council at its April 6 meeting.

The Program Committee is composed of Cooper and the section heads. The 1985 Annual Meeting will be held in New Orleans, August 29-September 1, 1985.

On behalf of the Program Committee, Cooper is soliciting from Association members paper suggestions and offers to appear as discussants for next year's meeting. In general, proposals for individual papers are preferred to proposals for whole panels.

Due to the lead time required for preparation of copy for the spring Preliminary Program, the deadline for receiving suggestions is December 1, 1984.

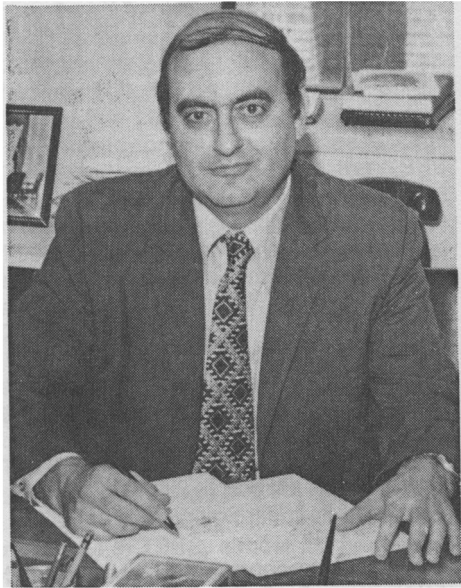
