The first three essays, by Henry C. Hart, James Manor, and Stephen P. Cohen, analyze the changes in India's important political institutions. The papers by Jyotirindra Das Gupta and Paul R. Brass focus on the relation between the state and ethnic activism.

The focus in the next three essays, by Pranab Bardhan, Francine R. Frankel, and Ghanshyam Shah, shifts to the political role of social groups and to the contribution that India's important castes and classes make to the political process. The concluding essay by Atul Kohli provides an overview of the changing state-society relations in India's democracy.

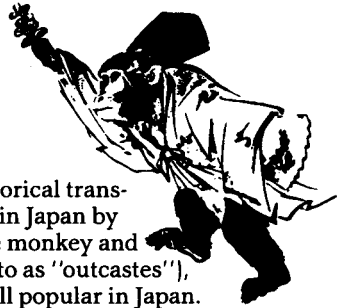
Symbolic Transformations in

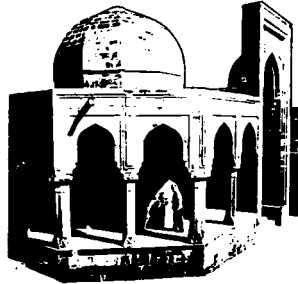
