Gabriella Eichinger Ferro-Luzzi THE SELF-MILKING COW AND THE BLEEDING LINGAM Criss-cross of Motifs in Indian Temple Legends 1987. XXIV, 254 pages, 8 plates, Pb. DM 84,-

The novel polythetic-prototype approach to myth, legend and other folk narrative proposed in the book, contrary to all major current theories on the subject, denies the existence of constants and accounts for resemblances among tales without recourse to hidden features. The first part demonstrates that the "cycle" of more than 450 related temple legends examined has no objectively given nucleus of motifs, sequence of functions, boundary and invariant structure. The second part deals with centres of gravity in the corpus which are partly culture-specific and partly culture-free. The former include Siva, the sacred cow, the cobra, the anthill and the rite of anointing the idol. The latter comprise certain motifs as well as favourite colours, numbers and structural elements, which Indian temple legends share with collective tales elsewhere.
