

A Prize In Political Science

The Brian Barry Prize



Since 2014, in partnership with Cambridge University Press and the *British Journal of Political Science* (*BJPoS*) the British Academy has awarded a prize in honour of Brian Barry, a distinguished Fellow of the Academy and founding editor of the journal.

Brian Barry was a distinguished moral and political philosopher whose work fruitfully combined analytic philosophy and political science, political theory and social choice theory. The prize is awarded annually for excellence in political science, as displayed in an essay submitted for the prize that has not been previously published and is not under consideration for publication elsewhere. The essay can address any topic in political science, as covered by *BJPoS*, but essays in fields related to the work of Brian Barry are especially welcome.

Essays may be submitted by anyone in possession of a first degree. Entries should be 8,000 to 10,000 words, with an abstract of no more than 100 words.

Entries may be submitted at any time, but to be eligible for the current Prize, please enquire.

Entries should be submitted electronically to submission.barryprize@cambridge.org. They should be in accordance with the journal's style sheet available on the journal homepage.

The Prize will be awarded by the Events and Prizes Committee of the British Academy, on the advice of a Prize Committee especially appointed to assess entries for the Brian Barry Prize.

The Prize, valued at £2,500 is usually awarded at a ceremony at the British Academy. Winning entries will be published in the *British Journal of Political Science*, possibly after revisions.

Notes for Contributors

All manuscripts should be submitted via our on-line system, ScholarOne Manuscripts at: <http://mc.manuscriptcentral.com/psrm>

Other forms of submission will not be accepted by the editors.

The journal publishes two types of articles:

- a) full length manuscripts that present original, well researched, and fully developed empirical or theoretical work
- b) research notes

Normal length articles that should not exceed 9,000 words in length, including tables, figures, footnotes, references and printed appendices, but excluding any supporting material that can be relegated to an online appendix.

Research notes that should not exceed 4,000 words in length, including tables, figures, footnotes, references and printed appendices, but excluding any supporting material that can be relegated to an online appendix.

Research notes should contain original work and present a new method or methodology (particularly useful if related software components are included) to solve an important problem in applied data analysis, present a new theoretical idea or argument, or comment on other articles published in the journal. *PSRM* welcomes comments to as well as replications of published articles. These will undergo the usual peer review process and if accepted will be published in the research notes section of the journal.

PSRM uses a single-blind peer review process, thus anonymizing your manuscript is not necessary. If you feel strongly about a fully anonymous review process, you may opt out and your manuscript will undergo a double blind review process.

Replication Policy: *PSRM* has a strict replication policy and authors are required to make replication material publicly available prior to publication of the article. The replication materials must be sufficient to replicate results in all tables and figures printed in the article, including simulation material for both theoretical (e.g. agent based models) and empirical (e.g. Monte Carlo experiments) work. Data and replication code for your article must be uploaded to the *PSRM* Dataverse. This is a necessary condition for publication of the manuscript. All manuscripts are accepted contingent on their replicability, which will initially be assessed by *PSRM* staff. Manuscripts that are not replicable will be rejected for publication.

Authors are responsible for obtaining permission to reproduce any material they do not own the copyright for and for ensuring appropriate acknowledgment of such material.

All manuscripts should follow the manuscript preparation guidelines available online in the full instructions for contributors.
