NOTES ON CONTRIBUTORS

DR ANN-MARIE AKEHURST teaches History of Art at the University of York. A Post-doctoral Fellowship from the Paul Mellon Centre for British Art is currently enabling her to complete a book on architecture and philanthropy in the eighteenth century. Her research interests include Early Modern urban culture, the English country house, and vernacular architecture. She is presently commencing a long-term project on the impact of early British colonialism in the Mediterranean.

DR TIMOTHY BRITAIN-CATLIN is the author of *The English Parsonage in the Early Nineteenth Century* (Spire Books, 2008), and has written for *The World of Interiors* for more than twenty years. He is an architect, and Senior Lecturer at the Kent School of Architecture, University of Kent. His most recent project has been a monograph on Leonard Manasseh & Partners for RIBA Publishing, in association with the Twentieth Century Society and English Heritage, to be published in October 2010.

DR MAARTEN DELBEKE is Associate Professor in the Department of Architecture and Urban Planning, Ghent University. He leads the Vidi-research project *The quest for the legitimacy of architecture, 1750-1850* in the Art History department at Leiden University. He studied architecture at the Department of Architecture and Urban Development at Ghent University (Belgium), obtaining his Ph.D. in 2001. From 2001 to 2003, he was the Scott Opler Fellow in Architectural History at Worcester College, Oxford, and in 2004 a visiting scholar at the Canadian Centre for Architecture.

DR FREDIE FLORÉ is Lecturer in Architectural History at the Vrije Universiteit Amsterdam and post-doctoral researcher at the Department of Architecture and Urban Planning, Ghent University. Her PhD, examining the history of discourses on 'good' or 'correct' living in Belgium in the period 1945-58, will be published in 2010 by Leuven University Press. Her current research focuses on the historiography of domestic architecture, home culture, the interior and design in the second half of the twentieth century. She is co-convenor of the seventh conference of the International Committee for Design History and Design Studies, Brussels 2010.

PROFESSOR VAUGHAN HART is Professor of Architecture and Head of the Department of Architecture and Civil Engineering at the University of Bath. He is an architect with a Ph.D. in Architectural History, and has written extensively on Early Modern architecture. His new monograph on Inigo Jones will be published in Spring 2011 by Yale University Press.

PETER HOWELL was Senior Lecturer in the Department of Classics at Royal Holloway, University of London. His teaching, spanning thirty-five years, covered art and architecture as well as language and literature. His publications on nineteenth-century architecture include chapters on 'Architecture, 1800-1914' in vol. vii of *The History of the University of Oxford* (Oxford, 2000).

JILL LEVER is past curator of the Drawings Collection at the Royal Institute of British Architects. She is presently consultant to the drawings cataloguing project at Sir John Soane's Museum, London. Her publications include scholarly catalogues of the drawings at the RIBA, a catalogue of the drawings by George Dance, senior and junior, in the collections of the Soane Museum (Oxford, 2003), and an online catalogue of the Museum's Soane sketchbooks.

PROFESSOR ROBERT MAXWELL is Associate Professor of the History of Art at the University of Pennsylvania. He teaches the art of the Middle Ages, specializing in the sculpture, architecture, and manuscripts of the Romanesque and Early Gothic periods, while also pursuing an interest in medieval art's historiography. He has also collaborated with several Philadelphia museums, serving as consulting curator to an exhibition of incunabula for the Rosenbach Museum & Library, and as a contributor to the installation of Romanesque sculpture and Gothic stained glass for the Glencairn Museum.

DR CHRIS MIELE is an architectural historian and chartered town planner who specializes in heritage matters. He is a Partner in the West End office of Montagu Evans LLP. His book on the United Kingdom Supreme Court is to be published in 2010; he is currently working on a biography of George Gilbert Scott.

ANNE-FRANÇOISE MOREL is a Ph.D. candidate at the Department of Architecture and Urban Planning at Ghent University. Her thesis, supervised by Maarten Delbeke, is entitled 'The construction of meaning in seventeenth- and eighteenth-century church architecture in England: a study of consecration sermons'

RICHARD PEARS, a historian, is faculty librarian at Durham University Library. He is researching the career of the Newcastle architect William Newton (1730-98) for a PhD at Newcastle University. An article on two castles by Newton appeared in vol. 16 of the *Georgian Group Journal* (2008).

DR ROBIN SKINNER is Senior Lecturer at School of Architecture, Victoria University of Wellington, where he teaches courses in history and Pacific architecture. His research and publications consider issues relating to the architectural history of New Zealand. He is currently President of the Society of Architectural Historians of Australia and New Zealand.
