SOME INFORMATION FOR CONTRIBUTORS TO THE AMERICAN JOURNAL OF INTERNATIONAL LAW

The *Journal* welcomes manuscripts on international law (including the history and theory of international law, international economic law, and private international law), the law of international organizations, and the foreign relations law of the United States and other countries. We do not publish:

- Contributions on foreign and comparative law.
- Contributions in languages other than English.
- Material that has already appeared or is about to appear in other journals or books, even if printed there in another language.

We are also pleased to receive manuscripts of shorter notes and comments.

We supply 50 reprints of articles and notes gratis to an author. Extra copies may be ordered at moderate cost.

OUR PROCEDURES

Manuscripts that are considered good possibilities for the *Journal* are sent out by the Editor-in-Chief to two or more readers on the Board of Editors. The Regulations of the *Journal* require that no manuscript may be published which has not received the approval of two members of the Board of Editors. Many contributors have told us that this process of careful review and the comments of the readers are very helpful and improve the quality of their manuscripts. We attempt to give as prompt a report as we can on the reactions of readers and of the Editor-in-Chief, but the process of reading and evaluation does take a certain amount of time.

We operate on roughly a four-month leadtime. Our publishing schedule is as follows:

Submission of material well in advance of the closing dates shown above facilitates its consideration by the *Journal*.

FORMAL REQUIREMENTS

1. Manuscripts (including footnotes) should be typed double-spaced. Footnotes should be cumulated at the end of the manuscript; footnotes

at the bottom of the page will be accepted so long as they are double-spaced.

2. Citations should conform to our style, which is basically that presented in *A Uniform System of Citation* (11th ed. 1967), published by the Harvard Law Review Association, Gannett House, Cambridge, Mass. 02138, U.S.A. This system is widely used by law journals in the United States.

3. The *Journal* prints about 450 words (including footnotes) to the page. We do not have any firm limit on the length of articles, but we do not favor articles over 30 printed pages. Short contributions are printed as notes.

4. Material submitted must be accurate and citations complete. We do not have the staff to check quoted and cited material against the original or to complete the author's work. Corrections in galley and page proof are very expensive. The cost of author's corrections in excess of one hour of composition time is billed to the author.

5. Authors in the United States submitting manuscripts are requested to furnish, if possible, three copies for reading; one of these will be returned if the manuscript is not accepted. The *Journal* takes all reasonable precautions to safeguard manuscripts sent to us but assumes no responsibility for the loss of manuscripts.

6. If a manuscript is submitted to us, the expectation is that the *Journal* is being given the exclusive right of original publication.
