

## NOTES ON THE CONTRIBUTORS

HENLEY ADAMS received his doctorate from the University of North Carolina at Chapel Hill. He teaches as an adjunct professor of political science at Baruch College of the City University of New York (CUNY). His research interests focus on race, national identity, and power in Latin America and the Caribbean.

JEREMY ADELMAN is the Walter Samuel Carpenter III Professor of Spanish Civilization and Culture at Princeton University. His recent works include, *Republic of Capital: Buenos Aires and the Legal Transformation of the Atlantic World* (Stanford University Press, 1999), and *Worlds Together, Worlds Apart: A History of the Modern World from the Mongol Empire to the Present*, co-authored with Robert L. Tignor, et al. (New York: W. W. Norton, 2002).

G. POPE ATKINS is Professor Emeritus of Political Science on the civilian faculty of the U.S. Naval Academy. From 1993 to 2001 he was Research Fellow at the Institute for Latin American Studies, The University of Texas at Austin. His books include *Latin America and the Caribbean in the International System* (4th ed., 1999), *Handbook of Research on the International Relations of Latin America and the Caribbean* (2001), and, with Larman C. Wilson, *The Dominican Republic and the United States: From Imperialism to Transnationalism* (Athens: University of Georgia Press, 1998).

MATT CHILDS received his Ph.D. in history from the University of Texas at Austin (2001). He joined the History Department at Florida State University in the fall of 2001. He has published articles in the *Journal of Latin American Studies*, *The Americas*, *The Historian*, and the *History Workshop Journal*. A co-edited volume with Toyin Falola titled *The Yoruba Diaspora in the Atlantic World* is forthcoming, and he is currently revising a manuscript on a slave insurrection in nineteenth-century Cuba known as the Aponte Rebellion of 1812.

J. TYLER DICKOVICK is a Ph.D. candidate at the Woodrow Wilson School of Public and International Affairs at Princeton University, where he holds a Wilson Society Fellowship. His dissertation examines intergovernmental fiscal relations in Brazil, Peru, Senegal, and South Africa.

KENT EATON is Assistant Professor of Politics and International Affairs at Princeton University. He is the author of *Politicians and Economic Reform in New Democracies: Argentina and the Philippines in the 1990s* (University Park: Penn State University Press, 2002) and a forthcoming book on the politics of decentralization and re-centralization in Latin America. His articles have appeared in *The Journal of Asian Studies*, *Comparative Politics*, and *Comparative Political Studies*.

BRODWYN FISCHER received her Ph.D. in history from Harvard University in 1999, and is currently Assistant Professor of History at Northwestern University. Her dissertation, "The Poverty of Law: Rio de Janeiro, 1930–1964," is a study of the legal bases of social inequality in

the Vargas and Populist eras. She is currently revising the manuscript for publication and beginning to work on a new project on the evolution of property rights in urban Brazil.

JONATHAN FOX is Professor of Latin American and Latino Studies at the University of California at Santa Cruz. He recently co-edited *Cross-Border Dialogues: U.S.-Mexico Social Movement Networking* (with David Brooks), *Demanding Accountability: Civil Society Claims and the World Bank Inspection Panel* (with Dana Clark and Kay Treakle), and *Indigenous Mexican Migrants in the U.S.* (with Gaspar Rivera Salgado; forthcoming). His recent articles have appeared in *Foro Internacional*, *Política y Gobierno*, and *Development in Practice*.

MERCEDES GONZÁLEZ DE LA ROCHA, social anthropologist, is a senior researcher at El Centro de Investigaciones y Estudios Superiores en Antropología Social (CIESAS) Occidente, Mexico. Among her main publications relating to marginality issues are: *The Resources of Poverty: Women and Survival in a Mexican City* (Oxford: Blackwell), and articles such as "From the Resources of Poverty to the Poverty of Resources? The Erosion of a Survival Model," and "Private Adjustments: Household Responses to the Erosion of Work."

MALA HTUN is Assistant Professor of Political Science at the Graduate Faculty of Political and Social Science of New School University. Author of *Sex and the State: Abortion, Divorce, and the Family under Latin American Dictatorships and Democracies* (Cambridge, U.K.; New York: Cambridge University Press, 2003), she has also published articles and chapters on gender quotas, women in politics, and women's rights. Htun's current work focuses on the representation of identity groups in contemporary democracies.

ELIZABETH JELIN is a senior researcher at CONICET (Consejo Nacional de Investigaciones Científicas y Técnicas) in Argentina. She is Research Director at IDES (Instituto de Desarrollo Económico y Social) and professor at the University of Buenos Aires. Her most recent publications are on memories of repression, social movements, and citizenship. Most recent books include *Los trabajos de la memoria* (Madrid and Buenos Aires: Siglo XXI Editores, 2002), *State Repression and the Labors of Memory* (University of Minnesota Press, 2003), and *Más allá de la nación: las escalas múltiples de los movimientos sociales* (Buenos Aires: Libros de Zorzal, 2003).

REX KOONTZ is Assistant Professor of Art at the University of Houston. His publications include *Mexico* (with Michael Coe; 5th ed., Thames and Hudson, 2002) and *Landscape and Power in Ancient Mesoamerica* (with Kathryn Reese-Taylor and Annabeth Headrick; Westview Press, 2001) as well as articles on Ancient Mesoamerican art and architecture.

IGNACIO LÓPEZ-VICUÑA earned his M.A. in Comparative Literature at the University of Massachusetts, Amherst, and is currently a doctoral candidate in the Department of Hispanic Languages and Literatures at the University of Pittsburgh. His research focuses on representations of

urban and public space in Latin American literature and film. He is working on his dissertation, which focuses on contemporary discourses and images of the urban experience in Latin American cities such as Buenos Aires, Mexico City, and São Paulo.

**JAMES E. MAHON, JR.** is Professor of Political Science and Chair of the Political Economy Program at Williams College. In the spring semester of 2003 he was a Visiting Scholar at the Centro de Investigación y Docencia Económicas (CIDE) in Mexico City. He is the author of *Mobile Capital and Latin American Development* (University Park: Pennsylvania State University Press, 1996) and a variety of articles on Latin American political economy, political-science methodology, and public policy.

**ANJA NYGREN** is Research Assistant Professor of Rural Sociology at the University of Missouri-Columbia. Her research on environmental conflicts in Central America has appeared in *Environmental Values*, *Critique of Anthropology, Development and Change*, and *Journal of Latin American Studies*. Her current research interests include environmental conflicts, forest certification, political ecology, protected area management, and politics of representation.

**JANICE E. PERLMAN** is Professor of Comparative Urban Studies at Trinity College and former tenured Professor in the Department of City and Regional Planning at the University of California, Berkeley. Her book, *The Myth of Marginality: Urban Poverty and Politics in Rio de Janeiro* (Berkeley: University of California Press, 1976), received the C. Wright Mills Award in 1976 and she is now engaged in a re-study of the original research participants and their children and grandchildren.

**BRYAN R. ROBERTS** holds the C.B. Smith, Sr. Centennial Chair (#1) in U.S.-Mexico Relations and is Professor of Sociology at the University of Texas at Austin, where he also directs the Center for Latin American Social Policy (CLASPO) at the Teresa Lozano Long Institute of Latin American Studies. Among his major books are *Cities of Peasants* (Beverly Hills: Sage Publications, 1978) and *The Making of Citizens* (London: Halsted Press, 1995). He currently serves as a member of LARR's International Editorial Board.

**HELEN I. SAFA** is Professor Emerita of Anthropology and Latin American Studies at the University of Florida (UF). She was formerly Director of the Center for Latin American Studies at UF and President of the Latin American Studies Association. She has published numerous books and articles focused on gender, race, development, and urbanization, particularly in the Hispanic Caribbean. Her book, *The Myth of the Male Breadwinner: Women and Industrialization in the Caribbean* (Boulder: Westview Press, 1995), analyzes women industrial workers in Puerto Rico, Cuba, and the Dominican Republic, while her earlier monograph *The Urban Poor of Puerto Rico: A Study in Development and Inequality* (New York: Holt, Rinehart, and Winston, 1974) has become a classic in urban anthropology.

FREDERICK SOLT, currently a Visiting Lecturer at Rice University, recently completed his Ph.D. in political science at the University of North Carolina at Chapel Hill. His dissertation was entitled "Explaining the Quality of New Democracies: Actors, Institutions, and Socioeconomic Structure in Mexico's States." He has also published articles on democracy and democratization in *Studies in Comparative International Development* and the *British Journal of Political Science*.

PETER WADE received his Ph.D. in Social Anthropology at Cambridge University, focusing on the black population of Colombia. He was a tenured Lecturer in Geography and Latin American Studies at the University of Liverpool (1988–1995). He is currently Professor of Social Anthropology at the University of Manchester. His publications include *Blackness and Race Mixture* (Johns Hopkins University Press, 1993), *Race and Ethnicity in Latin America* (Pluto Press, 1997), *Music, Race and Nation: Música Tropical in Colombia* (Chicago University Press, 2000), and *Race, Nature and Culture: An Anthropological Perspective* (London; Sterling, Va.: Pluto Press, 2002).

PETER M. WARD holds the C.B. Smith Sr. Centennial Chair (#2) in U.S.-Mexico Relations at the University of Texas at Austin, where he is also a professor in the Department of Sociology and Lyndon B. Johnson School of Public Affairs. Among his major books relating to marginality issues are: *Housing, the State and the Poor: Policy and Practice in Latin American Cities* (with Alan G. Gilbert, Cambridge University Press, 1985), *Welfare Politics in Mexico: Papering over the Cracks* (London: Allen and Unwin, 1986), and *Colonias and Public Policy in Texas and Mexico: Urbanization by Stealth* (Austin: University of Texas Press, 1999). He currently serves as the Executive Editor of LARR.
