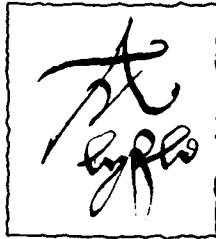

Other Ways of Growing Old

Theory and Society is an undogmatic, bi-monthly journal of the social sciences, produced by a worldwide fellowship of scholars who seek, through synthesis of sociology and marxism, to deepen understanding of the 'present as history' and to renew critical social theory. It is published for critical sociologists, independent marxists, and for other unpacified intellectuals and endangered species. Produced by scholars unencumbered by academic fences or by political piety, we write for those creating their own intellectual vision without buying packaged tours of the social world.

Theory and Society is a critic of both normal sociology and normal marxism. We are dismayed by academic sociology's propensity to

become an administrative instrument of state policy, and by many marxists' complicity in oppression. For example, by the Cambodian government's brutalization of its own people, Vietnamese invasion of Cambodia, Chinese invasion of Vietnam, not to speak of the Soviet Union's invasions of Hungary, Czechoslovakia and Afghanistan. *Theory and Society* is published by and for those who see no reason to choose between dinosaurs.

Theory and Society works to keep sociology and marxism open to one another, seeking to stimulate and to husband

social theory's great traditions. Preserving the viable work of Max Weber, Emile Durkheim, and Karl Marx, we also develop them in creative directions suggested (for example) by Antonio Gramsci, Barrington Moore, C. Wright Mills, Max Horkheimer, Eric Hobsbawm, Jürgen Habermas, Michel Foucault, and Raymond Williams. Rather than the partisan of some special theory, then, *Theory and Society* is the guardian of a larger theoretic culture. Subsidized neither by professional associations, universities, nor private benefactors, *Theory and Society* has grown only because it publishes work of excellence and interest to its readers.

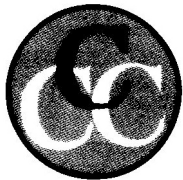

NOTES FOR CONTRIBUTORS

Contributions may be descriptive, analytical or theoretical. Any article not in itself comparative may be accepted if it lends itself to comment that will place it in comparative perspective. Correspondence with the editors prior to the submission of articles will help to enable them to obtain such comment or a companion study. Emphasis in comparative studies may be either on similarities or, if these are significant enough and call for some recasting of generalizations, on differences. All contributions and editorial correspondence should be sent to the Editors, *Comparative Studies in Society and History*, Department of History, University of Michigan, Ann Arbor, Michigan 48109.

Two copies of each contribution, preferably accompanied by a stamped, addressed envelope, should be submitted. Both text and footnotes should be clearly typed with double spacing and wide margins; footnotes should appear on separate pages at the end of the article. Illustrations may be included by arrangement with the editors.

Contributors will receive 50 offprints. Any additional offprints must be ordered on receipt of the first proof.
