PART VI, *Conflicts of Efficiency, Choice and Equality*, examines the issues of pollution and environmental conservation and their relationship to efficiency and prudent resource allocation. The "urban crisis" is discussed in terms of efforts to maintain patterns of extreme social inequality based on economic status and race.

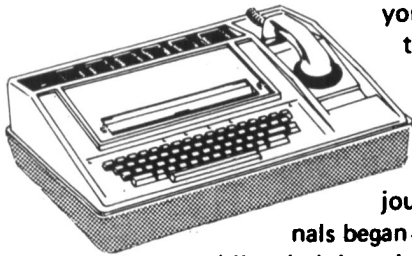

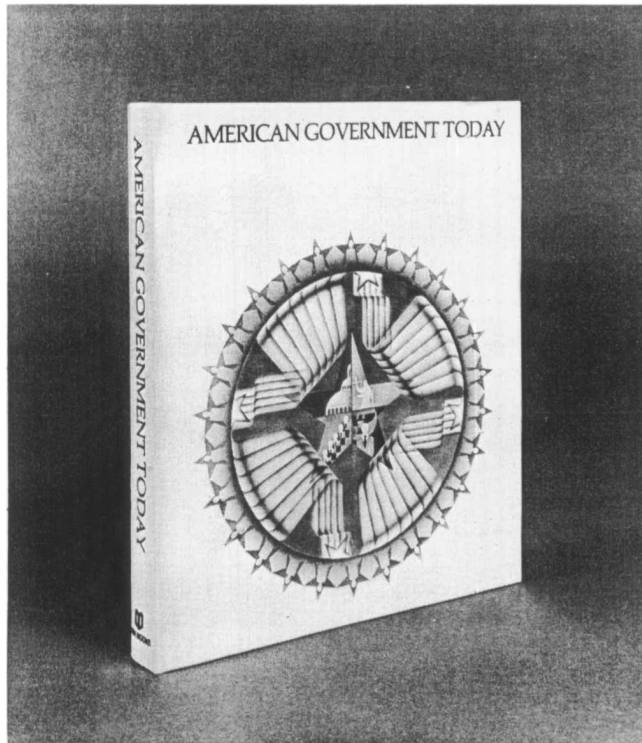

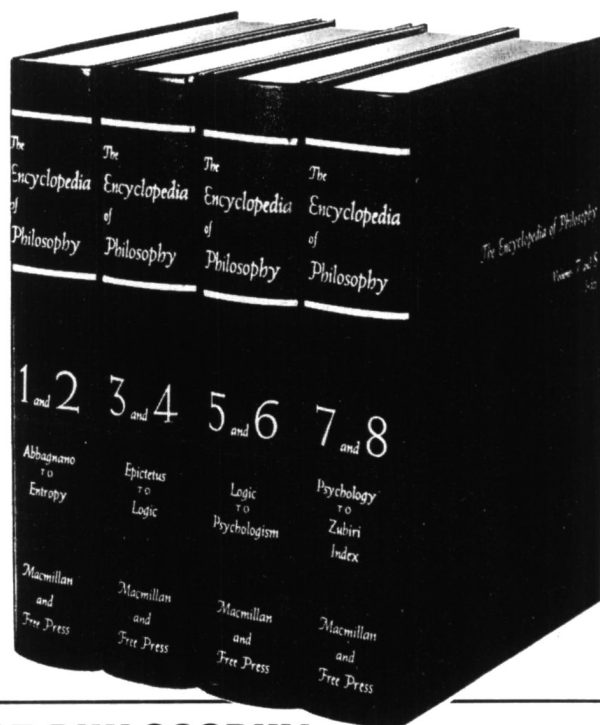

Condition of the Central City

by BENNETT HARRISON

According to the conventional view, the migration of industry and jobs to the suburbs has drained the central city economy and doomed its poor to ghettos and joblessness. The author questions this view and after surveying current research, offers a less despairing diagnosis. The long term conditions of the central city reflect national economic cycles. 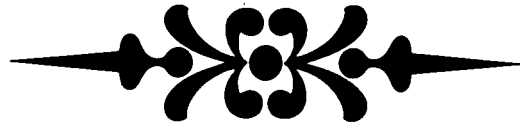

Deutsch's half of the bargain is a firm historical and theoretical framework, followed by a detailed look at the political systems of six major countries to see the theory in action. All of it written with wit, pith, and rare perception.

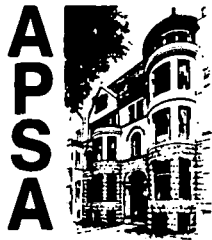
