CONTRIBUTORS

LANCE E. DAVIS is Mary Stillman Harkness Professor of Social Science at the California Institute of Technology. He is a past president of the Economic History Association and has worked in the areas of capital market integration and British imperialism. He and Robert Gallman are currently engaged in a long-term study of productivity change.

ALAN DERICKSON is assistant professor of labor studies and industrial relations at Pennsylvania State University. He received his M.P.H. from the School of Public Health, University of California, Berkeley, and his Ph.D. in the history of the health sciences from the University of California, San Francisco. He is the author of Workers' Health, Workers' Democracy: The Western Miners' Struggle, 1891–1925 (1988). He is at present investigating the history of coal miners' diseases.

ROBERT E. GALLMAN is Kenan Professor of Economics and History at the University of North Carolina at Chapel Hill and a research associate of the National Bureau of Economic Research. He is a former editor of the *Journal of Economic History* and of the *Southern Economic Journal*. He has published principally on the subject of nineteenth-century U.S. economic growth and is currently at work with Lance Davis and Teresa Hutchins on a book on the New Bedford whaling industry.

HENRY A. GEMERY is Dana Professor of Economics at Colby College. Two of his publications, "European Emigration to North America, 1700–1820; Numbers and Quasi-Numbers," *Perspectives in American History* (1984) and "Emigration from the British Isles to the New World, 1630–1700: Inferences from Colonial Populations," *Research in Economic History* (1980), focus on the number of migrants who undertook the trans-Atlantic journey. His current research is addressed to migration in the early national period.

TERESA D. HUTCHINS is assistant professor of economics at Ramapo College of New Jersey. She received her Ph.D. in economics from the University of North Carolina, Chapel Hill, in 1988. Her research continues to center on the topic of her dissertation, "An Investigation of the American Whale Fishery."

RICHARD W. JUDD received his Ph.D. in history from the University of California, Irvine, in 1979 and is assistant professor of history at the University of Maine. He is the author of Aroostook: A Century of Logging in Northern Maine (1989) and Socialist Cities: Urban Politics and the Grass Roots of American Socialism, as well as of several articles on resource and conservation issues in Maine politics. He has served on the editorial staff of Forest History and is currently editor of the Maine Historical Society Quarterly.

JAMES T. LEMON is professor of geography at the University of Toronto. He is the author of *The Best Poor Man's Country: A Geographical Study of Early Southeastern Pennsylvania* (1972) and most recently of "Agriculture and Society in Early America," *Agricultural History Review* (UK) (1987), and of "Colonial America in the Eighteenth Century," in *North America: The Historical Geogra-*

phy of a Changing Continent, ed. Robert Mitchell and Paul Groves (1987). He is writing a book on urban development in North America in a world context.

JOHN J. McCUSKER teaches at the University of Maryland, College Park, is a student of the economy of the seventeenth and eighteenth centuries, and serves on the Editorial Advisory Board of the Business History Review. His most recent books are Rum and the American Revolution: The Rum Trade and the Balance of Payments of the Thirteen Continental Colonies (1989), and, with Cora Gravesteijn, The Commodity Price Currents, Exchange Rate Currents, and Money Currents of Early Modern Europe: The Beginnings of Commercial and Financial Journalism (forthcoming).

DIANNE NEWELL is associate professor of history at the University of British Columbia. She is the author of Technology on the Frontier: Mining in Old Ontario (1986) and The Development of the Pacific Salmon-Canning Industry: A Grown Man's Game (forthcoming, 1989), and coauthor (with Ralph Greenhill) of Survivals: Aspects of Industrial Archaeology in Ontario (1989).

E. A. WRIGLEY is a Senior Research Fellow, All Souls College, Oxford. He was formerly professor of population studies at the London School of Economics and Political Science and is a cofounder of the ESRC Cambridge Group for the History of Population and Social Structure. His publications include Population and History (1969); The Population History of England, 1541–1871: A Reconstruction (1981) (with R. S. Schofield); People, Cities, and Wealth: The Transformation of Traditional Society (1987); and Continuity, Chance, and Change: The Character of the Industrial Revolution in England (1988).
