HOHOKAM AND PATAYAN

PREHISTORY OF SOUTHWESTERN ARIZONA

EDITED BY RANDALL H. McGUIRE and MICHAEL B. SCHIFFER

Southwestern Arizona contains a rich and varied record of prehistoric occupation that extends back over 12,000 years. This volume summarizes and evaluates the results of several unpublished studies conducted in this region, and introduces several new ideas on methods and theory in prehistoric study. Part I considers the nature of prehistoric synthesis as related to the study area's environment, and the ethnographically studied Indian societies that live in southwestern Arizona. Part II critically evaluates previous research on the region's cultural history and extends the Hohokam and Patayan chronologies. In Part III the chapters address problems of archaeological surveys in areas of low site density; tabulate primary site data; and propose recommendations for managing the archaeological resource base. The volume concludes with an extensive set of appendices.

This ethnohistoric and archaeological study of the western Pueblo offers new approaches to understanding the political organization and economic structure of the Puebloan cultures. It models archaeological data using techniques adapted from economic geography and world-systems theory; stresses the political importance of ritual knowledge and ceremonial position; and provides a new explanation for the widespread abandonment of the northern Southwest that occurred between A.D. 1400 and 1450.

PREHISTORIC FORAGING IN A TEMPERATE FOREST

A LINEAR PROGRAMMING MODEL

This volume offers a unique blend of theory, method, and data. The author develops a detailed optimal foraging model for studying past behavior and examines various hunting and gathering adaptations to the deciduous forest of southern Michigan in the late Archaic period. The linear programming model considers the precise effects of resource seasonality, diversity, and mobility patterns of human subsistence and settlement. The model emphasizes the importance of nutrition to economic decision making and reveals several misconceptions about diet in the current archaeological literature.

This interdisciplinary study covers subsistence practices in the Maya region of Mexico, Guatemala, Honduras, and El Salvador from approximately 1500 B.C. to the present. The work contains the proceedings of a conference held in Dennis E. Puleston's memory at the University of Minnesota in October 1979. The opening chapter analyzes Puleston's contribution to the history of inquiry into Maya subsistence. Subsequent chapters explore early Guatemalan agriculture; Classic Period intensive farming systems; the sixteenth century Spanish encounters with Mayan agricultural and economic systems; the use of animals; women's economic roles; and the efforts of modern botanists to revive ancient methods of farming.


