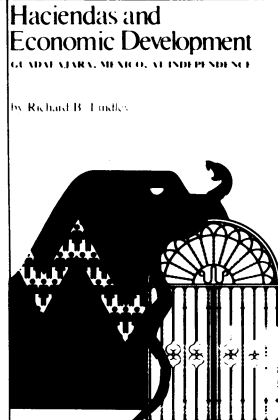
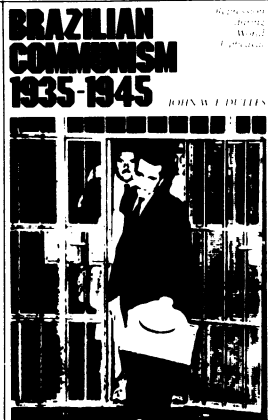

WILLIAM L. CANAK, formerly Visiting Assistant Professor of Sociology at Brown University, is now a research associate with *Organizational Analysis and Practice*, Boardman House, 120 East Buffalo Street, Ithaca, New York 14850.

JEFFREY A. COLE is in the Department of History at the State University of New York at Oswego. He wrote this article while a Mellon Fellow at the Center for Latin American Studies at Tulane University. He recently published another article on this general topic in the *Hispanic American Historical Review*.

IVÁN JAKSIĆ is a research associate at the Center for Latin American Studies at the University of California in Berkeley. He previously taught at the State University of New York at Buffalo. He is coediting with Jorge J. E. Gracia a forthcoming book entitled *Filosofía e identidad cultural en América Latina*.

FRÉDÉRIC MAURO is professor of Latin American history at the University of Paris X—Nanterre and at the Institute of Advanced Latin American Studies at the University of Paris III—Nouvelle Sorbonne. He has published some twenty books, most dealing with the Luso-Brazilian world.

JOHN A. BOOTH is Associate Professor of Political Science at the University of Texas at San Antonio. He published *The End and the Beginning: The Nicaraguan Revolution* (1982) as well as several articles on Central America. He and Mitchell A. Seligson coedited *Political Participation in Latin America, Volumes One and Two* (1978, 1979).

MITCHELL A. SELIGSON is Associate Professor of Political Science at the University of Arizona. He wrote *Peasants of Costa Rica and the Development of Agrarian Capitalism* (1980), coauthored *Maquiladoras and Migration: Workers in the Mexico–United States Border Industrialization Program* (1982), and has published several other articles on land reform, democratic theory, and political tolerance in Latin America.

BECKY BOLING received her Ph.D. from Northwestern University in 1982. She is currently Assistant Professor of Spanish at Carleton College in Northfield, Minnesota.

LOUIS A. PÉREZ, JR., is Professor of History at the University of South Florida.

HERALDO MUÑOZ is a researcher at the Centro de Estudios de la Realidad Contemporánea at the Academia de Humanismo Cristiano and a professor at the Instituto de Estudios Internacionales in Santiago. He edited *From Dependency to Development* (1981) and has published various works on international politics.

JOHN SHEAHAN is Professor of Economics at Williams College and has chaired the Center for Development Economics there. He has worked in the Colombian

planning department, taught at the Colegio de México, and conducted research in Peru. He has published articles on problems of development in these three countries and on relationships between economic strategies and political repression in Latin America.

ASUNCIÓN LAVRIN *edited and coauthored Latin American Women: Historical Perspectives (1978). She has written mostly on colonial women and the colonial church in Mexico. She is currently preparing a book on early-twentieth-century feminism in South America.*

BRADLEY A. SHAW *is Associate Professor in the Department of Modern Languages at Kansas State University. He has published on topics ranging from Latin American bibliography to contemporary Spanish and Spanish American fiction. He was Assistant Editor of the Journal of Spanish Studies: Twentieth Century and is currently Associate Editor of Studies in Twentieth-Century Literature.*

RICHARD GRISWOLD DEL CASTILLO *teaches in the Mexican American Studies Department at San Diego State University. He wrote The Los Angeles Barrio, 1850–1890: A Social History and is currently completing a book on the history of Mexican American families in the Southwest.*

JAMES L. DIETZ *is Professor of Economics and Director of Latin American Studies at the California State University at Fullerton. He is also the coordinating editor of Latin American Perspectives. The author of numerous articles on Puerto Rico, he has written the forthcoming work entitled A Political Economic History of Puerto Rico since the Nineteenth Century.*

JOHN W. SLOAN *has written several articles on Latin American and inter-American politics. He recently completed a book-length study of comparative public policy in Latin America.*

LOWELL GUDMUNDSON *is currently Assistant Director of the Latin American and Caribbean Center at Florida International University. He taught at the Universidad Nacional and the Universidad de Costa Rica and has written three books and several articles on Costa Rican social and economic history.*

CARLOS HUNEEUS *was a researcher associated with the Institute of Political Science at the University of Heidelberg, where he received his Ph.D. He is currently a researcher at the Centro de Estudios de la Realidad Contemporánea de la Academia de Humanismo Cristiano in Santiago.
