I have pleasure in presenting the 11th Annual Report of the Children's Bureau.

The Bureau continues to operate without full-time professional staff and this restricts the operation at all levels

We are grateful to the many people who offer their services in a voluntary capacity — without whom the Bureau would be unable to function.

There is no doubt that the urgent priority of the new Board is to set about raising sufficient funds for the appointment of full-time staff. This is vital if the Bureau is to meet its objectives.

The Bureau continues to publish a high quality journal on Child & Family Welfare — it is involved in National Marriage and Family Week and distributes 26,000 brochures during May on behalf of the National Marriage and Family Week Council.

During the year the former Director, Mr. Graeme Gregory, the Secretary, Rev. Denis Oakley, and the Chairman of the Publications Committee, Mr. John Edwards, produced a paper on the National Survey which was delivered at the 4th International Congress on Child Abuse and Neglect in Paris in September 1982.

The paper was entitled 'Australian Children in Substitute Care', and has been published in the Journal 'Australian Child and Family Welfare', Volume 8, Number 1.

BOARD OF MANAGEMENT

Mr. John Taylor did not seek re-election as a Board Member at the Annual Meeting held in Canberra owing to his Agency committments. Mr. Taylor has held several positions with the Bureau — we thank him for his contribution.

Ms. Clancy's title for her address was "Reconstructed Families and their Children", and raised many thought provoking issues.




