

NOTES ON THE CONTRIBUTORS

ANIBAL ROMERO is Professor of Political Science at the Simón Bolívar University in Caracas. He was a visiting scholar at the Hoover Institution at Stanford University and at the David Rockefeller Center for Latin American Studies at Harvard as well as a research affiliate at the Olin Institute for Strategic Studies at Harvard. His most recent books are *La sorpresa en la guerra y la política* and *Decadencia y crisis de la democracia*.

KURT WEYLAND, Assistant Professor of Political Science at Vanderbilt University, recently published *Democracy without Equity: Failures of Reform in Brazil*. He is also the author of several articles on public policy making in Brazil and on democratization, market-oriented reform, and neopopulism in Latin America.

STERLING EVANS is a Ph.D. candidate in Latin American history at the University of Kansas. His areas of interest are the diplomatic and environmental history of Central America and Mexico. He is the author of *A Conservation History of Costa Rica*, forthcoming from the University of Texas Press.

DOUGLAS C. LIBBY has been on the faculty of the Department of History at the Universidade Federal de Minas Gerais for fifteen years. He has published books and articles on the slave society of Minas Gerais in the eighteenth and nineteenth centuries focusing on such topics as foreign-owned gold mines, local iron foundries operated by slaves, textile proto-industrialization, and slave demography. He is currently studying a gender conflict in the workplace that occurred in Minas Gerais in the late colonial period.

DAVID J. MYERS is Associate Professor of Political Science at the Pennsylvania State University. Having lived and traveled in Latin America since 1966, he has written or edited five books and numerous articles and essays on the region. His research interests include public opinion, political parties, and comparative urban politics.

Professor of History at the University of California, Irvine, **STEVEN C. TOPIK** is the author of *Trade and Gunboats: The United States and Brazil in the Age of Empire* and co-editor with Allen Wells of *The Second Conquest? Latin American Export Economies in the Age of Imperialism* (in press).

DONALD G. RICHARDS is Associate Professor in the Department of Economics at Indiana State University, where he teaches courses in international economics. He received two Fulbright Fellowships for research in Paraguay and Argentina and has written several articles on the political economy of trade and finance issues facing the Southern Cone region of South America.

JOHN F. SCHWALLER is Associate Provost and Professor of History at the University of Montana. He also serves as Director of the Academy of American Franciscan History. His work includes several pieces on the history of the Catholic Church in colonial Latin America. At present he is studying the life of don Luis de Velasco, the Younger, Viceroy of Mexico and Peru.

ROBERT D. SHADOW is Professor of Anthropology at the Universidad de las Américas–Puebla in Mexico. He recently co-edited with Carlos Garma Navarro

a collection of essays on pilgrimage in Mexico and is currently preparing with María Rodríguez-Shadow a book manuscript on the agrarian and social history of Mora County, New Mexico.

MARIA RODRIGUEZ-SHADOW is a senior researcher in the *Dirección de Etnología y Antropología Social* at the *Instituto Nacional de Antropología e Historia* in Mexico. She has published two books, *La mujer azteca* and *El estado azteca*, and has coauthored with Robert Shadow several articles on women in pre-Hispanic, colonial, and contemporary Mexico.

KATHLEEN LOGAN is Associate Professor in the Department of Sociology and Anthropology at Florida International University. She is currently working on an edited volume of writings by Maya political activist Araceli Cob Cumi and is coauthoring a book manuscript with Juan Castillo Cocom on Yucatec Maya political history. Her scholarly interests include qualitative research methodology, politics, gender, and indigenous issues.

ENI DE MESQUITA SAMARA is Professor of History at the Universidade de São Paulo in Brazil. She specializes in the study of family and women's history as well as in historical demography. She has written various articles and books, including *A família brasileira* and *As mulheres, o poder e a família*.

DORA ISABEL PAIVA DA COSTA is a Visiting Researcher at the Centro de Estudos de Demografia Histórica da América Latina (CEDHAL). She is pursuing a Ph.D. in history.

PIERO GLEIJESES is Professor of U.S. Foreign Policy at the Johns Hopkins School of Advanced International Studies. His most recent book is *Shattered Hope: The United States and the Guatemalan Revolution, 1944–1954*.

VICTOR M. URIBE is Assistant Professor of History at Florida International University. He recently published articles on the history of colonial lawyers in New Granada and their participation in the region's independence movement. He is currently completing a book manuscript on lawyers and state formation in New Granada from 1750 to 1850.

SILVIA ROSMAN is Assistant Professor of Latin American Literature at Bates College in Maine. She is currently completing a book manuscript on concepts of nation, community, and citizenship in the Latin American essay.
