Walter L. Adamson is the Samuel Candler Dobbs Professor of Intellectual History at Emory University. He is currently working on the politics of religion in Fascist Italy. He is the author of *Embattled Avant-gardes: Modernism's Resistance to Commodity Culture in Europe* (University of California Press, 2007); *Avant-garde Florence: From Modernism to Fascism* (Harvard University Press, 1993), *Marx and the Disillusionment of Marxism* (University of California Press, 1985); and *Hegemony and Revolution: A Study of Antonio Gramsci's Political and Cultural Theory* (University of California Press, 1980).

Ana Aguado is Professor of Contemporary History and member of the Institute of Women's Studies at the University of Valencia. She is a specialist in social history and the history of women in contemporary times. Her research interests are focused on the study of political cultures, and the collective action of women and gender identities in twentieth-century Spain. She is currently working on the relations between political modernisation, democracy and the development of equitable thinking in Spanish socialist culture. Her published works include *La modernización de España: Cultura y vida cotidiana: 1917–1939* (Síntesis, 2002) and (edited with Teresa Ortega) *Feminismos y antifeminismos: Culturas políticas e identidades de género en la España del siglo XX* (Universidad de Valencia, 2011).

Patrick Bernhard is Assistant Professor of European History at Trinity College Dublin and the author of *Zivildienst zwischen Reform und Revolte: Eine bundesdeutsche Institution im gesellschaftlichen Wandel, 1961–1982* (Oldenbourg 2005). He is currently writing a book on the transnational interrelationships that shaped racist social engineering in Nazi Germany and Fascist Italy.

Lucia Coppolaro is a post-doctoral research fellow at the Institute of Social Sciences of the University of Lisbon. Her research interests lie mainly in the fields of the economic and political history of contemporary Europe, the political economy and history of international trade. She has written widely on GATT and the European Union's trade policy and has published numerous articles in journals including *International History Review* and *Journal of European Integration History*. Her recent publications include *The Making of a World Trading Power: The European Economic*

Community (EEC) in the GATT Kennedy Round Negotiations (1963–67) (Ashgate, 2013) and, as editor with Francine McKenzie, *A Global History of Trade and Conflict since 1500* (Palgrave Macmillan, 2013).

Shannon Monaghan is a doctoral student in History at Boston College and a graduate fellow with the Clough Center for the Study of Constitutional Democracy. Her primary research interest is in the transnational history of the First World War as well as the inter-war period. She is currently preparing a dissertation on population engineering in western Europe after the First World War.

H. Glenn Penny is Associate Professor of European History at the University of Iowa. He is the author of *Objects of Culture: Ethnology and Ethnographic Museums in Imperial Germany* (University of North Carolina Press, 2002) and *Kindred by Choice: Germans and American Indians since 1800* (University of North Carolina Press, 2013). He is also the editor (with Matti Bunzl) of *Worldly Provincialism: German Anthropology in the Age of Empire* (University of Michigan Press, 2003) and (with Laura Graham) *Performing Indigeneity* (Nebraska University Press, 2014). He is currently pursuing a series of projects on Germans in Latin America.

Maren Röger is a postdoctoral-research fellow at the German Historical Institute in Warsaw. She has published widely on German and Polish history of the 20th century, focussing on the post-war remembrance of the expulsions, for example *Flucht, Vertreibung und Umsiedlung: Mediale Erinnerungen und Debatten in Deutschland und Polen seit 1989* (Herder, 2011) and gendered aspects of the Second World War II. Together with Ruth Leiserowitz, she has edited the volume *Women and Men at War – A Gender Perspective on the Second World War and its Aftermath in Central and Eastern Europe* (fibre-Verlag, 2012). Currently she is finishing a monograph entitled *Sexual Policies and Sexual Realities in German Occupied-Poland: Prostitution, Fraternalization, Sexual Violence*.

Cezar Stanciu is Assistant Professor at Valahia University in Romania and senior researcher at the Grigore Gafencu Center for the History of International Relations. He has published several articles and books in Romania, Finland and the United Kingdom on Romania's foreign policy during the Communist regime. Areas of interest: Romanian-Soviet relations, Romania's foreign policy in the Cold War, ideology in International Relations. Recent publications include: 'Communist Regimes and Historical Legitimacy: Polemics Regarding the Role of the Red Army in Romania at the end of the Second World War', in *European Review of History/Revue européenne d'histoire*, 20, 3 (2013) and 'Crisis Management in the Communist Bloc: Romania's Policy towards the USSR in the Aftermath of the Prague Spring', in *Cold War History*, 13, 3 (2013).

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Articles submitted for publication should be sent electronically to *Contemporary European History*, at ceh@sheffield.ac.uk, or, in the case of submissions from North America, to the Corresponding Editor for North America, Tara Zahra, tzahra@uchicago.edu

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers should send a final version via email. This should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short biographical note with a description of work in progress and previously published work (130 words max.)
