The work of the French architect Claude-Nicolas Ledoux has fascinated art historians, social critics, and architects alike since the French Revolution. Criticized in his own time for extravagance and megalomania, Ledoux has since been hailed as a visionary and utopian, and as a radical neoclassicist. In the 1930s, Ledoux's designs were seen as anticipating modernist abstraction in architecture, and more recently have been mined as a source of postmodern imagery.

Vidler studies a number of Ledoux's urban projects—most notably, the Pal-

ace of Justice of Aix-en-Provence, the Theater of Besançon, and the tollgates around Paris—as examples of Ledoux's attempt to create a "modern classicism" that would reinvest ancient forms with contemporary meaning.

A product of detailed research into late-eighteenth-century cultural and social history, this book examines Ledoux's controversial life and work in the context of the Revolutionary period, and discusses his education, early career, and the development of his personal idiom as a domestic architect.
