

NOTES ON THE CONTRIBUTORS

CLAUDIO BELINI obtained his doctorate from the University of Buenos Aires in 2004. He is a postdoctoral fellow at the Argentine Consejo Nacional de Investigaciones Científicas y Técnicas (CONICET) and a junior researcher at PEHESA (a research program of the Dr. Emilio Ravignani Institute of Argentine and American History at the University of Buenos Aires). His research interests include industrial history and public policies of the first half of the twentieth century. He has recently published "Política industrial e industria siderúrgica en tiempos de Perón, 1946–1955," *Ciclos en la economía, la política y la sociedad* no. 28 (2004).

GLEN BIGLAISER is Assistant Professor of Political Science at Texas Tech University. He is the author of *Guardians of the Nation?: Economists, Generals, and Economic Reform in Latin America* (University of Notre Dame Press, 2002). His research interests include the effects of politics on economic development. His work has appeared in *Comparative Political Studies*, *International Studies Quarterly*, *Political Research Quarterly*, and other publications.

DIANE E. DAVIS is Professor of Political Sociology in the Department of Urban Studies at MIT, and Associate Dean of the School of Architecture and Urban Planning. She is the author of *Urban Leviathan: Mexico City in the Twentieth Century* (Temple University Press, 1994; Spanish translation 1999) and *Discipline and Development: Middle Classes and Prosperity in East Asia and Latin America* (Cambridge University Press, 2004), as well as co-editor of *Violence, Coercion, and Rights in the Americas* (Sage Publications, 2000) and *Irregular Armed Forces and Their Role in Politics and State Formation* (Cambridge University Press, 2003). Her current research, supported by the Carnegie Corporation of New York and the John D. and Catherine T. MacArthur Foundation, examines the evolution of policing and the relationship between police impunity and deteriorating rule of law in cities of the developing world.

KARL DEROUEN, JR. is Associate Professor in the Department of Political Science at the University of Alabama. His research interests are conflict processes and international political economy. Current research is on the role of domestic institutions in civil war onset and duration. His work has appeared in *Journal of Politics*, *Journal of Conflict Resolution*, *British Journal of Political Science*, and others.

REGINA HORTA DUARTE is Associate Professor of History at the Federal University of Minas Gerais (UFMG), Brazil. She has published as *A Imagem Rebelde* (1991), *Noites Circenses* (1995), and *O Circo em Cartaz* (2002), and articles in several Brazilian and international journals (*Revista*

brasileira de história, Varia história, Iberoamericana, Environment and History, Manguinhos, Estudos Iberoamericanos, Luso-Brazilian Review). Her current work researches the relationship between biology and politics in the 1930s, in Brazil.

CHRISTIAN GUNDERMANN is Assistant Professor of Spanish at Mount Holyoke College. He completed doctoral studies in literature and film at Cornell University (1999) and Rutgers University (2002), and specializes in twentieth-century Latin American literature and cinema, especially in contemporary Argentinean film and post-dictatorship poetry and prose. He has recently published articles on the Argentinean Neobarroque as a challenge to Queer Studies, on the status of history in Alejandro Agresti's cinema, as well as on politics and aesthetics in the New Argentinean Cinema. He is also preparing a book manuscript on melancholia and resistance in post-dictatorship culture.

DAVID R. HANSEN was an undergraduate in economics at Brigham Young University at the time he participated in this research. He has since begun a Ph.D. program in economics at Stanford University. His current research interests include the design of microfinance programs and their capacity to develop human capital.

KIRK A. HAWKINS is an assistant professor of political science at Brigham Young University. He recently completed a Ph.D. at Duke University, where he wrote his dissertation on party system breakdown and the emergence of charismatic political movements in Latin America. He currently studies charismatic politics, populism, and political parties in Latin America, and he has recently published work on Chavismo in *Third World Quarterly*.

GARETH A. JONES is Senior Lecturer in Development Geography at The London School of Economics as well as an Associate Fellow of the Institute for the Study of the Americas, University of London. In 2004 he was a Visiting Fellow at the University of Texas at Austin where he held a Leverhulme Study Abroad Fellowship and is presently directing a major ESRC funded project entitled "'Being in Public': The multiple childhoods of Mexican 'street' children" (2005–2007). He is presently completing an edited book (with Dennis Rodgers) on youth and violence in Latin America and a monograph on alternative modernities in the Mexican city.

PETER KINGSTONE received his Ph.D. from the University of California, Berkeley. He teaches Latin American politics and political economy at the University of Connecticut, where he is also Director of the Center for Latin American and Caribbean Studies. He has published two books on democracy and economic reform in Brazil with Penn State University Press and University of Pittsburgh Press (co-edited with Timothy Power). He has also published a number of articles on various aspects of the politics of economic reform in journals such as *Comparative Politics*, *Comparative Political Studies*, and *Latin American Politics and Society*.

MARIANA LLANOS (D.Phil in Politics, Oxford, 1999) was, between 2001 and 2004, a member of the project, "Bicameralism and the Senates in the Southern Cone," which was carried out at the Institut für Iberoamerika-Kunde in Hamburg, Germany, with the financial support of the Deutsche Forschungs Gemeinschaft. She is the author of *Privatization and Democracy in Argentina* (Palgrave 2002) and has several other publications on political institutions in Latin America (for instance, in *The Journal of Latin American Studies*, *The Journal of Legislative Studies*, *Desarrollo Económico*). She currently teaches at the University of Hamburg and continues conducting research on the legislatures of the Southern Cone.

SHARLENE MOLLETT is currently a PhD Candidate in the Department of Geography at the University of Toronto whose research explores the politics of natural resource access in Honduras and examines the interplay between race and property rights in the Rio Platano Biosphere Reserve. Her dissertation research has been funded by the doctoral award programs at the International Development Research Centre (IDRC) in 2003 and the Social Science and Humanities Research Council of Canada (SSHRC) in 2004.

VALENTINA NAPOLITANO QUAYSON is a Lecturer in the Dept. of Anthropology, University of Sussex, UK and she is the author of *Migration, Mujercitas and Medicine Men, Living in Urban Mexico* (University of California Press, 2002) and, with Leyva Solano, *Encuentros Antropológicos: Power, Identity and Mobility in Mexican Society* (Institute of Latin American Studies, 1998). She is currently working on the gendered understandings of breast cancer and frontier medicine in Monterrey, Mexico, and on gendered subject formation of religious and lay Latino transmigrants in Rome.

JENNIE PURNELL is Associate Professor of Political Science at Boston College. She is the author of *Popular Movements and State Formation in Revolutionary Mexico: The Agraristas and Cristeros of Michoacán*. She is currently working on a book on war, nationalism, and state formation at the local level in nineteenth-century Oaxaca.

FRANCISCO SÁNCHEZ (Doctorate in Political Science, University of Salamanca, 2004) participated on the "Bicameralism and Senates in the Southern Cone" project from 2001 to 2004. The project was carried out at the Institut für Iberoamerika-Kunde in Hamburg, Germany, with the financial support of the Deutsche Forschungs Gemeinschaft. He has published several works on Latin American political institutions, in *América Latina Hoy*, *Perfiles Latinoamericanos* and *Revista de Estudios Políticos*. He currently holds a post-doctoral research grant at the University of Salamanca.

CLIFF WELCH has been teaching history at Grand Valley State University in Michigan since he received his Ph.D. from Duke University in 1990. From 2003 to 2005, he was a Visiting Foreign Professor of Social

Sciences, Geography and History in the graduate schools of the Pontifícia Universidade Católica de São Paulo and the Universidade Estadual Paulista (UNESP) in Presidente Prudente. He is currently visiting research fellow at UNESP's Núcleo de Estudos, Pesquisas e Projetos de Reforma Agrária. Among his major publications are *The Human Tradition in Modern Brazil* (Schoalrly Resources, 2004), and *The Seed Was Planted: The São Paulo Roots of Brazil's Rural Labor Movement, 1924–1964* (Penn State Press, 1999). His documentaries include *Latino Voices* (1998), *Grass War!* (2001) and *Sonhando com futebol* (2004). He is currently working on a book about land conflict in Brazil from 1959 to 1999.

ROBERT H. WILSON is the Mike Hogg Professor of Urban Policy at the Lyndon B. Johnson School of Public Affairs at the University of Texas at Austin. He has published broadly on urban policy, community development, development and technology policy and public policy in Brazil. His books include *Public Policy and Community: Activism and Governance in Texas* (The University of Texas Press, 1997), *States and the Economy: Policymaking and Decentralization* (Praeger, 1993), and *The Political Economy of Brazil: Public Policies in an Era of Transition* (University of Texas Press, 1990). He is currently working on segregation and urban services and metropolitan governance in the Americas.
