

MINUTES OF THE PSYCHOMETRIC SOCIETY BUSINESS MEETING

July 2, 2008

Paul de Boeck called the meeting to order at 5:15 P.M. 36 members of the Society were present.

Minutes from the 2006 Business Meeting that were published in the December, 2007 issue of *Psychometrika* were approved without any changes.

Luz gave the Treasurer's report. At the start of 2007 fiscal year our balance was \$305,793. At the end of the 2007 fiscal year our balance was \$295,420. Our current funds to date were \$453,113. A motion to accept the Treasurer's report without modification was passed

Luz presented the report of the Membership Committee. Currently there are 778 total members: 522 regular members, 236 student members, and 20 Emeritus members. Members represent 52 countries. She nominated 53 individuals for regular membership into the Society. A motion to accept these individuals for regular membership was passed. A list of regular members is presented below.

Brian Junker reported on the Editorial Council Meeting. He reported that there was discussion of the purpose/role of ARCS Section. He also reported that a new Publication Editor would be hired and that this individual who would be a member of the Psychometric Society and a psychometrician. This person would receive a small stipend like the ARCS Editor or perhaps be unpaid. The purpose of the position would be quality control of the final draft of the articles for the journal or Springer Online. Checking such things as the way tables are set, catching typesetting errors, etc. would be the focus.

Brian also discussed the online review system, Editorial Manager. This has been in place for four or five months and the transition has basically been smooth. Problems such as the system not accepting PDF files and comments of the editors being forwarded to the author have been solved. The system at this point does not create an archive for documents but Gwen has been able to manage that. It has been decided that the Greensboro office will handle the CD-ROM update.

It was decided that there would be a special section in the journal for the Dissertation Award winner similar to the one for the Presidential Address. The Editor would be responsible for asking the winner if they are interested in submitting a paper based on their dissertation. The editor would then be the person to help if the paper needs work rather than a reviewer. Finally,

Brian mentioned that Mark Wilson will take over as the new book review editor.

Brian brought up the Springer contract renegotiation. There are only two major changes. One is the addition of the Publication Editor and the second is the agreement that any articles older than 10 years would be available free of charge. The contract will be signed in January, 2009.

Paul discussed the Board of Trustees Meeting. He reviewed the new prizes that were established including an award for the Best Poster and the Best Presentation. These winners will receive \$500 plus a plaque. The Career Award winner will receive \$500, a plaque, plus travel money up to \$1,500. Conference fees for the winner will be waived. It was decided to convert the Career Award to two awards: an Early Career Award and a Lifetime Achievement Award. It was decided to open nominations for the awards to the membership. These awards would be explained in the fall mailing. The final determination of the winner will be done by the president-elect, the current president and the past-president and the secretary.

Paul mentioned that a committee made up of the past president, the present president, the president elect and Terry will look at the by-laws and what needs to be done to get them into alignment with the Society's current practices.

Terry Ackerman reported on the election results. Our new president-elect is Jos ten Berge. Mark Wilson was elected to the Editorial Council and the two newly elected Trustees are Mark Reckase and Henk Kelderman.

Mike Nering reported on the New Hampshire meeting. In all there were three workshops, six state-of-the-art sessions, three keynote addresses, six invited lectures (semi-plenary), 16 invited sessions, 27 contributed sessions, seven TIDE sessions and one poster session. In all 325 registered for the meeting. Seventeen countries were represented, the top five were the US, the Netherlands, Japan, Canada and Belgium/Korea.

The 2009 IMPS is scheduled to be held at St. John's College in Cambridge, England. John Rust, Director of the Psychometric Centre at the University of Cambridge is heading the organizing committee. The conference will be Monday, July 20–Thursday, July 23.

The meeting was adjourned at 5:53 P.M.
