## **The Fall of the Royal Government in Peru**

*By Timothy E. Anna*

Peru was one of the last Spanish American colonies to become independent, and historians have long puzzled over why it was so slow to achieve separation from Spain. Focusing on the royalists, Anna presents a new perspective on Peruvian independence and clarifies a large number of misunderstood points.

Tracing the course of events from the royalist regime of Viceroy Abascal through the final defeat of the royalist forces at the battle of Ayacucho and the Siege of Callao, Anna argues that Peruvian independence came by default rather than through positive choice. Peruvians avoided committing themselves until the question was finally settled by force of arms.

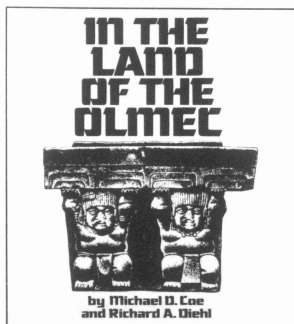

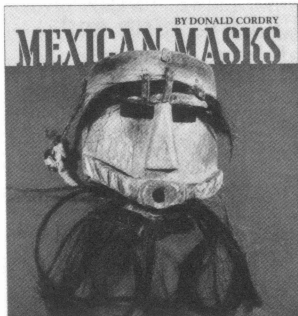

## NOTES ON THE CONTRIBUTORS

**HÉCTOR PÉREZ BRIGNOLI** is Professor of History at the University of Costa Rica. His areas of research interest are economic and demographic history of Latin America in the nineteenth and twentieth centuries and the use of quantitative methods in history and the social sciences in general. He is the author, with *Ciro F. S. Cardoso*, of *Historia económica de América Latina* (1979).

**BENIGNO AGUIRRE** is Assistant Professor in the Department of Sociology and Anthropology at Texas A&M University. His recent publications include "Jehova Witnesses in Latin America" (*Sociological Analysis* 1979) and *Sociología de la Conducta Colectiva* (forthcoming).

**KENT P. SCHWIRIAN** is Professor of Sociology and Department Chairman at Ohio State University. His research focuses on the assimilation of ethnic groups in the cities of developed and developing countries. He is also studying the ecological structure and change of Puerto Rico's metropolitan areas.

**ANTHONY J. LA GRECA** is Director of the Urban and Regional Research Center and Associate Professor of Urban Sociology and Ecology at the University of Florida. His main research interests center around residential neighborhoods, urban ethnic and racial segregation, and the life cycle of urban subcommunities. He is currently investigating the autonomy and viability of retirement communities.

**SUSAN BERK-SELIGSON** is a sociolinguist at the University of Arizona. Her work on Costa Rican Spanish phonology has appeared in *Lingua* and the *American Journal of Political Science*. Her current research interest is phonological variation in judeo-español.

**PIERRE-MICHEL FONTAINE** is Associate Professor in the Department of Political Science and Faculty Research Associate in the Center for Afro-American Studies at the University of California at Los Angeles. His research interests are politics, political economy, and race relations in Brazil and the Caribbean.

**CATALINA H. WAINERMAN**, a Social Psychologist, **ZULMA RECCHINI DE LATTES**, a Demographer, and **RUTH SAUTU**, a Sociologist, have been members of the research staff of the *Centro de Estudios de Población (CENEP)*, Buenos Aires, since 1974.

**GLENN O. PHILLIPS** is Assistant Professor of History at Morgan State University. He is currently conducting a study of nineteenth-century Caribbean migration. He is the coauthor of *Towards the Preservation of a Heritage: Catalog of Howard University Museum* (1979).

**JUAN RIAL** is a Research Associate with the *Centro de Informaciones y Estudios del Uruguay*, Montevideo. His current research concern is urban history and historical demography. He is the author, with *Jaime Klaczko*, of "Uruguay: el país urbano" (forthcoming).

**PENNY LERNOUX** is Latin American correspondent for *The Nation* and a contributing editor of *Inquiry*. Her articles on contemporary Latin America won her the 1976 *LASA* award for journalism. She has written extensively on the Catholic Church in Latin America, including *Cry of the People* (1980).
