Matthew Broad is an EU-funded Marie Skłodowska-Curie Individual Fellow in the Department of Philosophy, Political Science and Contemporary History, University of Turku, Finland. His research interests include British foreign policy, European integration and Anglo-Nordic relations. Publications include *Harold Wilson's Danish Connection: The British Labour Party, Danish Social Democrats and European Policymaking, 1958–72* (Liverpool University Press, forthcoming 2017) and 'Awkward partners? The British Labour Party and European integration in the 1970s', in Guido Thiemeyer and Jenny Raflak, eds., *European Political Parties and the First Direct Elections to the European Parliament* (Baden-Baden, 2015). He is currently working on an institutional history of the European Free Trade Association (EFTA) from 1960 until 1992.

Emma De Angelis works on the construction of European identity and the relationship between conflict, war and culture in contemporary Europe. She is the Editor of the *RUSI Journal*.

Eirini Karamouzi is Lecturer in Contemporary History at the University of Sheffield. She is the author of *Greece, the EEC and the Cold War, 1974–1979. The Second Enlargement* (Palgrave Macmillan, 2014) and a co-editor of a volume on the Balkans in the Cold War. She is currently working on Greek peace movements during the Cold War and is one of the directors of the Cultures of the Cold War network.

Veera Mitzner is a Visiting Scholar at Columbia University. After receiving her PhD from the European University Institute, Florence, in 2013, she worked as a Postdoctoral Researcher at the Network for European Studies, University of Helsinki, and Visiting Lecturer at the University of Turku. In 2011 she was a Visiting Scholar at the École des Hautes Études en Sciences Sociales, Paris. Her principal research interests include the history of European political and economic integration, EU history, research policy and the history and politics of the Nordic countries.

Emmanuel Mourlon-Druol is the author of *A Europe Made of Money: The Emergence of the European Monetary System* (Cornell University Press, 2012) and has recently edited, with Federico Romero, *International Summits and Global Governance*:

The Rise of the G7 and the European Council, 1974–1991 (Routledge, 2014). Other publications include ‘‘Managing from the Top’’: Globalisation and the Rise of Regular Summity’, *Diplomacy & Statecraft* 23:4 (December 2012) and ‘Filling the EEC Leadership Vacuum? The Creation of the European Council at the December 1974 Paris Summit’, *Cold War History* 10:3 (August 2010). He is currently working on the development of European banking regulation and supervision from the 1960s.

Eric Pullin is Associate Professor of History and Asian Studies at Carthage College. He specialises in teaching the history of India and the United States. Pullin’s publications include ‘The Bandung Conference: Ideological Conflict and the Limitations of US Propaganda’, in *Neutrality and Neutralism in the Global Cold War* (2015); ‘The CIA and the Congress for Cultural Freedom: Covert Operations and Cultural Affairs’, in *Intelligence History Now and Then* (2013); ‘Money Does Not Make Any Difference to the Opinions That We Hold: India, the CIA, and the Congress for Cultural Freedom, 1951–1958’, in *Intelligence and National Security* (2011); ‘Noise and Flutter: U.S. Propaganda in India during World War II’, in *Diplomatic History* (April 2010) and ‘The Indian Civil Conflict, 1946–1949’, *A Guide to Civil Wars of the World* (2007). He is currently completing his first book, ‘Noise and Flutter’: *India, Propaganda, and Global Ideological Conflict, 1942–1964*.

Linda Risso is Associate Professor in Modern History at the University of Reading. She is an expert on the history of European integration and the Cold War. Her most recent monograph, *Propaganda and Intelligence: The NATO Information Service*, was published by Routledge in 2014.

Umberto Tulli received his PhD in History and International Relations from the Istituto Italiano di Scienze Umane (now: Scuola Normale Superiore) in 2011. He is currently a postdoctoral fellow at the School of International Studies, University of Trento. He is the author of two books, *Breve storia delle Olimpiadi*, 2012, and *Tra diritti umani e distensione. L’Amministrazione Carter e il dissenso in Urs*, 2013, and a number of articles in Italian and English. He is currently working on the European Parliament during the 1970s and the introduction of direct elections in the Community.

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Authors wishing to submit articles for publication should do so through the journal's online submissions system at <http://mc.manuscriptcentral.com/conteurohistory>.

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers will be expected to submit a final version which should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short biographical note with a description of work in progress and previously published work (130 words max.)
