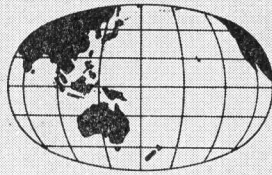

A description of the gradual consolidation of Kuomintang domination in China follows and to conclude there is a discussion of its principles of political development and of the considerable success of its construction programme which were largely brought to nought by the outbreak of war in 1937.
