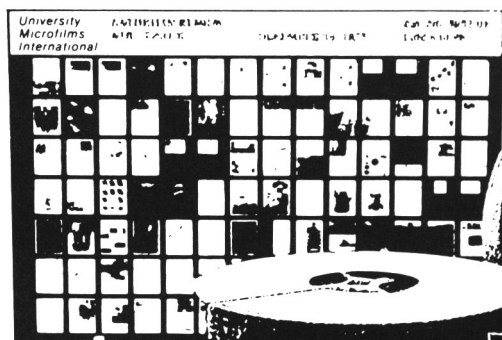

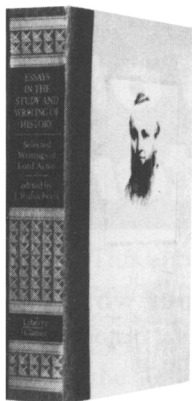

Lord Acton's concept of Liberty was the theme of the Essays collected in the first volume of this edition, *Essays in the History of Liberty*. In this volume may be found the historical studies upon which Acton drew to explicate his understanding of the idea of liberty.

Writing on such diverse topics as the divorce of Henry VIII, Leopold von Ranke, and the History of the Papacy, Acton argued his position that history demonstrated progress and unity through the story of liberty.

Included here are Acton's most important historical essays from his days as a scholarly journalist and his famous Inaugural Lecture at Cambridge in 1895, "The Study of History."

These two volumes, edited by J. Rufus Fears, Professor of Classical Studies at Boston University, will be followed by a concluding volume entitled *Essays in Religion, Politics, and Morality*.

This book presents for the first time the fascinating world history of mission and ministry through the centuries to men and women of the sea. The monumental task of locating and collating the material in the book has taken the author more than 15 years of painstaking research.

The main body of the book traces the absorbing saga of seamen's missions, from their earliest origins through their formative years as an organized outreach ministry of the Christian church. It covers almost 18 centuries of sporadic endeavor, beginning with Christ calling seafarers as his very first followers, to the development of compassionate missions to seamen in the British, American and European naval and merchant fleets during the 18th and 19th centuries. A final section discusses the principles and practices of a "Maritime Missiology," relating the preceding narrative to significant issues on the current scene.

ROALD KVERNDAL, Executive Secretary of the multi-denominational International Council of Seamen's Agencies, was awarded a Doctorate of Theology by Oslo University in 1984 for his dissertation, upon which this book is based.

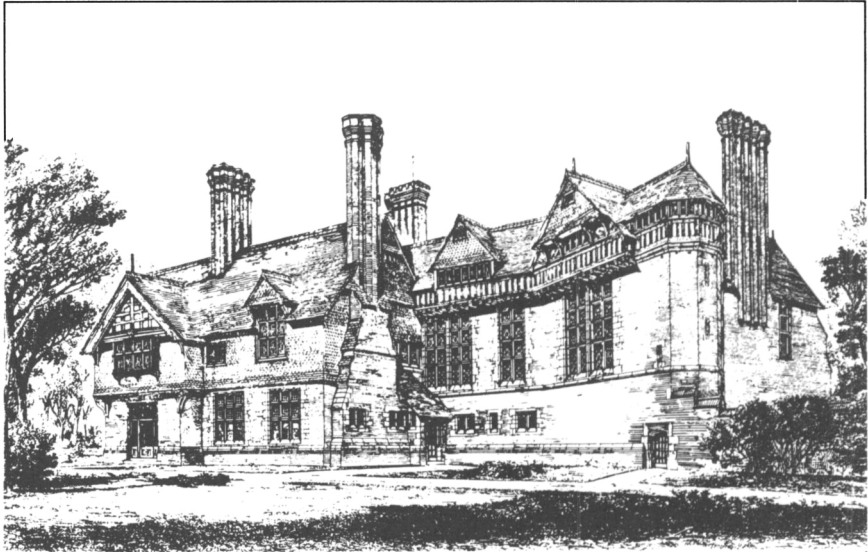
